**Abstract:** The Solomon Stevenson Collection consists of correspondences, photographs, documents, and other items about World War II, and the African American community in Evansville, IN from 1920 to 1996.

**Historical Notes:** Solomon Stevenson was born on March 14, 1909 in Kansas City, KS and served as a captain in the United States Army. Solomon was decorated with the American Campaign, Asiatic Pacific and Victory service medals. For more than forty years, Stevenson was a civil rights leader in Evansville, IN and worked together with the National Association for the Advancement of Colored People (NAACP). He was the owner of Stevenson Realty and Insurance Company. Stevenson was actively involved with the Evansville Metropolitan Development Board, Civil Rights Commission, Welborn Hospital Foundation, Evansville Board of Realtors, Human Relations Commission, and Liberty Terrace Housing Authority Board. He and his wife Alberta Kathryn (nee McFarland) were married 54 years and had one daughter, Lorraine. Stevenson passed away on April 22, 2002.
