Historical Notes: Shaw was born February 15, 1923 in Evansville, Indiana. She graduated from Central High School, the University of Alabama (Bachelor of Arts degree), Columbia University (Master's Degree), University of Michigan (Medical Degree), and University of Houston (Law Degree). She was an associate professor of medical genetics at the University of Michigan's Medical School. She moved to Houston, Texas in 1967 and formed the Health Law Institute at the University of Texas in 1979 until her retirement in 1988. Shaw served as a visiting professor at Yale University, University of North Carolina, and University of Utah. She helped to draft genetic legislation, which led to the establishment of Medical Genetics Institute and served as a consultant on the artificial heart and AIDS epidemic. She served as president of the Genetics Society of America and American Society of Human Genetics. Shaw received numerous

awards such as Achievement Award in 1970 from the American Association of University Women and Who's Who in America. She was married to her husband, Charles, and together had one daughter. Shaw passed away on July 28, 2012.
