Abstract: This collection consists of statements, reports, correspondences, and other items from the Southern Indiana Higher Education, Inc. at the University of Southern Indiana in Evansville, Indiana from 1966 to 2008

Historical Notes: The Southern Indiana Higher Education, Inc. (SIHE) was formed to aid in bringing higher education to Evansville and was instrumental in the forming of Indiana State University Evansville and University of Southern Indiana. In 1967, SIHE raised nearly \$1 million to acquire 1,400 acres for the Mid-America University Center. Groundbreaking was held June 22, 1968. Since September 1969, the University has occupied 330 acres, mostly donated by SIHE. On April 16, 1985, legislation was signed which made USI a separate state university. All legal matters were effective July 1, 1985. On June 30, 2008, SIHE transferred ownership of over 900 acres of land and remaining assets to the USI Foundation.
