Abstract: This collection consists of minutes, agendas, and other items from the Board of Trustees at the University of Southern Indiana in Evansville, Indiana from 1965 to 2021.

Historical Notes: The Board of Trustees was established in 1985 after independence from Indiana State University. The collection holds board minutes from Indiana State University from 1973 to 1985 and board minutes from University of Southern Indiana from July 1, 1985, to present. The board is made up of nine trustees, including a student trustee, who are appointed by the governor of the state of Indiana, governing the university.
