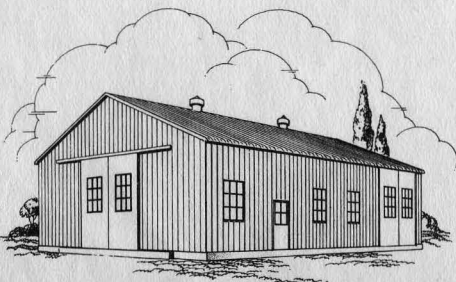

Dear Mr. Mesker:

On March 6th, we sent Mrs. Mesker \$5,000.00 and when the insurance was collected Mrs. Mesker was to advise us whether this was to be returned or charged to Ledger A. & M. In order to keep our records straight, we are charging this to Ledger A. & M. as we do not need it and would suggest that you enter same on your books accordingly.

I spent ten days in the latter part of July at Lake George which is near Angola, Indiana. I drove to Indianapolis, then over to Culver and then to South Bend, Angola and a little later to Coldwater, Michigan, and up to Detroit and coming back we took another route. I did this to see just how much building was going on. On our entire trip the only building I saw was remodeling a store at Huntington, Indiana and also one at Coldwater, Michigan, for the A. & P. Company. The only Highway work I saw was relaying two blocks of street in Dearborn, Michigan and building a small bridge at Ypsilanti, Michigan. This gives you an idea of the small amount of building going on.

Our year started out very nicely but July was terrible. We are receiving very few inquiries, in fact, the only jobs we are getting are brought in by our salesmen. There has not been enough building for the last two years to justify us to subscribe for clippings and we have done practically no advertising for two years.
