I am happy to report to you that the Alumni Association has not been the victim of a post-Christmas slump. The first three months of 1988 have been full of activity and accomplishment.

Homecoming 1988 was a great sucess. The Country Fair and picnic buffet lured alumni families in greater numbers than ever before. There were games for the kids, ice cream, lemonade, a pie-eating contest, lots of good food and lots of folks we haven't seen at Homecoming for quite a while. We were even on the 10 O'Clock News!

Our legislative reception in Indianapolis was well attended by both state and local officials and representatives of the Evansville business community.

Attendance at the Alternate Site Alumni Reception was hampered by an ill-timed ice storm which paralyzed Indianapolis less than an hour before the pre-game buffet was to start. However, those who braved the slick roads were treated to a family-style chili dinner and an informal reception during halftime.

This spring also saw the start of two new alumni programs. The first is a general assistance fund for alumni groups who need seed money to organize reunion activities.

The Executive Council voted to award \$50 to the first 20 alumni groups who request financial assistance and to limit the award to one per group per year.

In the second program, USI graduates are asked to provide professional and career assistance and advice for USI students. Many of you already may have received a card asking for your help, and I hope that the response continues to be as generous as it has been these last few weeks.

The big story this spring, however, is the Telefund Drive. Fundraising Committee Chairman John Schutz took the annual appeal well over the goal of \$35,000, with the final pledge total more than \$40,000. John and his army of callers did pretty well statistically, too. The number of alumni contacted increased, the average pledge went up, and the number of pledges was higher than last year. Congratulations, John and committee!

Remember that there are many ways to support the University and Alumni Association. Certainly, we appreciate and need your donations, but we need your participation and involvement too.

Our alumni are more numerous, more diverse, and more widespread with each graduating class. Just as USI is assuming a larger role and enjoying greater influence in the Indiana education community, so are USI alumni in their respective professional and residential communities.

## SOUTH BEND BANKER IS COMMENCEMENT SPEAKER

Ernestine Morris Raclin, a leader in business, education, and civic affairs in South Bend who has been called "Indiana's First Lady of Banking," brought the Commencement Address at the University of Southern Indiana's 1988 Commencement.

The ceremony was held at 9:30 a.m. Saturday, May 14, in the Physical Activities Center. The University conferred its first master's degrees and nearly 500 USI students received B.S., B.A., and A.S. degrees.

Mrs. Raclin was honored by conferral of an honorary Doctor of Laws degree in recognition of her contributions to education, business, and community on local, state and national levels. Other honorary degree recipients included Dr. Arthur E. Bestor, emeritus professor of history at the University of Washington, who received an honorary Doctor of Letters degree in recognition of his pioneering scholarship on New Harmony, Indiana; and Donald B. Cox, Evansville Realtor and business, civic, and political leader who received an honorary Doctor of Laws degree in recognition of his leading role in and continuing support for the development of USI as Indiana's sixth state university.

Mrs. Raclin is chairman of the Board of 1st Source Corporation and 1st Source Bank in South Bend, which with \$1 billion in assets is the largest banking concern in northeast Indiana and southwest Michigan. She was an early leader in South Bend/St. Joseph County economic development programs, and also is a director of First Chicago Corporation, First National Bank of Chicago, and the Northern Indiana Public Service Company of Hammond, Indiana. Her contributions to education in recent years include serving as trustee of the University of Notre Dame, where she is co-chairman of its \$150-million fund drive, and Converse College in Spartanburg, South Carolina; life trustee and president emeritus of the board of The Stanley Clark School of South Bend, a private elementary school; Director of Associated Colleges of Indiana; and a member of the Advisory Board of Indiana University-South Bend.

Dr. Bestor began his research at the Workingmen's Institute Library in New Harmony in the mid-1940s. During those early visits, he organized the archives at the Institute Library, which is Indiana's oldest surviving public library. Dr. Bestor's New Harmony research provided much of the material for his classic study of American communalism, Backwoods Utopias, The Sectarian and Owenite Phases of Communitarian Socialism in America: 1663-1829, first published in 1950. His numerous books include the 1948 publication of Education and Reform at New Harmony and Correspondence of William Maclure and Marie Fretageot. Dr. Bestor holds two Ph.D.s from Yale University, a master's from Oxford University, and an honorary LL.D. from Lincoln University. He was professor of history at Washington University from 1962 until his retirement, and has held active memberships in many professional organizations.

Cox was chairman of the fundraising campaign for the University Home, serves on the board of the USI Foundation, and was active in the legislative and administrative process that led to USI being established as the sixth state university in Indiana in July, 1985. A real estate broker, Cox is an active member of numerous professional organizations and is board chairman of Pro-Eco, Inc.; president of Mid Continent Insurance Agency, Inc.; a director of National City Bank; director and vice chairman of Welborn Baptist Hospital Board; and director, executive committee member, and vice chairman for governmental affairs of the Evansville Chamber of Commerce. An active Republican for more than two decades, he is among Governor Robert D. Orr's "kitchen cabinet" advisors, was elected National Committeeman by Indiana Republicans in 1984, and has been an ex-officio member of the Republican State Committee since 1984.

# PROFESSOR GEORGE EADIE SELECTED FOR NATIONAL SME AWARD

George R. Eadie, professor of mining engineering technology, was one of 13 engineers in the nation selected to receive the 1988 Distinguished Member Award of the Society of Mining Engineers. The awards were presented at the recent SME annual meeting in Phoenix, Arizona.

Eadie lives in Eldorado, Illinois, where his family has operated rental property, landscaping, and mining engineering consulting businesses. He has been with USI since 1976.

Eadie was nominated for the award on the basis of his contribution to the development of mining engineering technology in the Illinois Basin coal industry and to SME. The nomination states: "... (Eadie) recognized the need of the coal industry in the '70s to develop technically educated people to manage the expected expansion and when these needs did not materialize, he successfully redirected the focus of the mining engineering technology program which he heads, to emphasize engineering principles and provide graduates needed in the independent coal operations in the Tri-State. Through his field trip activities, professional society participation, and consulting practice, he has earned the respect and confidence of area coal operators and educators."

## HOW TO GIVE MORE FOR LESS USING APPRECIATED STOCKS OR BONDS

Why would someone give securities, such as stocks, bonds or shares of mutual funds, rather than simply writing a check? For many givers, this is the most economical way of making their gifts.

New federal tax laws continue to offer special incentives for gifts of non-cash property. Just as cash gifts to qualified charitable organizations such as the USI Foundation are deductible from federal income tax returns for itemizers, gifts of non-cash property such as stocks also are deductible.

The cost of giving long-term stocks, which have increased in value, may never be lower. The deductible amount includes both what you paid and your gain (that is, full fair market value), as long as you have held the stock for at least six months and a day.

Example. John and Mary Smith usually make an annual gift to the USI Foundation of \$500. This year they want to increase their gift to the \$1000 President's Council level, but they want to do this in the most economical way.

The Smiths own 100 shares of XYZ stock purchased in July 1985 for \$400. Now, the shares are worth 1000.

Should the Smiths give the shares of stock, or sell and give the cash? Or should they take \$1000 out of income and give cash? The tax benefits may make the difference in their decision, as the table below shows.

A. If they give \$1000 in cash:	
Value of gift	\$1000
Value of deduction (@33% maximum marginal

#### B. If they sell the securities and give the proceeds:

The Smiths decided the best plan would be to give the 100 shares of XYZ stock (Option C), rather than selling them and giving cash (Option B). The \$728 in tax savings (Option C) represents an after-tax return of 82 percent on their original \$400 investment. And, they enjoy making a gift that leaves their cash available for other uses.

#### ASWA AWARD NAMED AS MEMORIAL TRIBUTE TO ROSIE NEWHOUSE



The Rosie Newhouse ASWA Scholarship has been established as a memorial tribute to Rosemarie Wiseman Newhouse, who was USI manager of financial systems at the time of her death in December, 1987.

A major gift from her husband Jerry Newhouse, along with many memorial contributions received in her memory, will endow this scholarship as a perpetual tribute to Mrs. Newhouse. A University employee since 1974, Rosie Newhouse began as a temporary part-time secretary in the Division of Allied Health. After transferring to the Office of Business Affairs, she was promoted to various administrative positions including senior accountant.

The accounting scholarship award, originally sponsored by chapter of the American Society of Women Accountants, has been renamed in memory of Rosie Newhouse, who was a past president. The ASWA Chapter also will remain a co-sponsor of the scholarship, and continue to its annual \$200 contribution. The award is made each year at Honors Day.

#### BURGDORFS WILL ENDOW SCHOLARSHIP IN MEMORY OF HER PARENTS

Bert and Jack Burgdorf, long-time supporters of the USI Varsity Club, have made a major gift toward the endowment of a scholarship in memory of Mrs. Burgdorf's parents, Frances H. and Guy Q. Cornell, Sr.

The Burgdorfs, of 1314 Reiter Drive, both swimmers and frequent users of the PAC facilities, remember how often her parents stressed the importance of education to their eight children. They hope to help meet college expenses for the recipients of the Cornell Memorial Scholarship.

Mrs. Burgdorf's memory of her mother's desire to learn to swim and dance is reflected in the criteria she has outlined for awarding the scholarship. Eligibility criteria will include being a young woman, who is a swimmer or participant in a minor sport, and who maintains a 3.0 out of a possible 4.0 grade point average.

The scholarship, which will provide a \$500 award annually toward tuition and fees, will remain inactive until the \$10,000 endowment level is reached. The award will be based on financial need.


## ACADEMIC AFFAIRS ORGANIZES INTO FIVE SCHOOLS

The USI Board of Trustees has approved a restructuring of Academic Affairs to create five schools — Business, Education and Human Services, Liberal Arts, Nursing and Health Professions, and Science and Engineering Technology. The restructuring is a result of a study by a faculty task force appointed by USI President David Rice to "study the present structure of Academic Affairs and develop a plan to establish an organizational structure appropriate for the University's present stage of development and to accommodate future institutional progress." The task force recommended not only the formation of the schools, but also departments within the schools.

The new structure is a more traditional way of organizing a university which offers baccalaureate and graduate programs. Because it organizes the disciplines into departments, it clarifies lines of communication and responsibility. According to Dr. Robert Reid, vice president for Academic Affairs, it also will allow the University to be more effective in organizing curriculum and accommodating the changes that has come with a growing University. Dr. Sandra Singer, member of the task force who directs graduate studies said a departmental organization in schools is especially important at the graduate level. "Degree programs must evolve from departments," she said. Dr. Singer also pointed out that this organization will give faculty and students a strong sense of identity and could enhance research opportunities for both faculty and students. Assessment of programs, including comparative analyses with other universities, also will be more meaningful stated Dr. Reid.

In the new structure, the School of Business will include the departments of accounting, business education and computer information systems, economics and finance, and management and marketing. The School of Education and Human Services will include the departments of education, physical education, and social work, and will oversee the Bachelor of General Studies program. Departments in the School of Liberal Arts will include art and music, communications, English, foreign languages, history, political science and philosophy, psychology, sociology and anthropology. The School of Nursing and Health Professions will include nursing and allied health. The School of Science and Engineering Technology will include biology, engineering technology, and mathematics. Deans will lead each of the new schools and chairmen will be appointed to administer departments and programs within each school. In addition there will be two administrators to oversee graduate studies and extended services


## THREE DEANS ARE APPOINTED

At the March meeting of the Board of Trustees, President David L. Rice announced the appointment of three of the five deans for the newly structured schools. They are Dr. James R. Blevins, chairman of the USI Division of Humanities, who will become dean of the School of Liberal Arts; Dr. Frank Stanonis, chairman of the USI Division of Science and Mathematics, who will become dean of the School of Science and Engineering Technology; and Dr. Nadine A. Coudret, who has been dean of the School of Nursing at the University of Evansville, who will become dean of the School of Nursing and Health Professions.

Dr. Blevins has been with USI since 1966 and chairman of the division since 1970. He received his B.A. from David Lipscomb College, M.A. and Ph.D. from George Peabody College, and completed two terms of post-doctoral work at the University of California at Los Angeles. He is an active member of various University and community organizations devoted to enhancement of the arts. Dr. Blevins was instrumental in the organization of a USI Society for the Humanities to broaden the

influence of the University and the community upon each other in the development of humanities programs.

Dr. Stanonis, who joined the faculty in 1969, resumed the chairmanship of the Division of Science and Mathematics in 1986, having served previously from 1973 to 1979. He took a one-year leave of absence in 1976 to serve as commissioner for environmental quality for the Commonwealth of Kentucky. A geologist, he received his B.S. and M.S. from the University of Kentucky and his Ph.D. from Pennsylvania State University. He operated a geological and exploration consulting firm in Henderson, Kentucky, prior to joining the USI faculty.

Dr. Coudret's numerous professional affiliations currently include member, Indiana State Board of Nursing; director, UE Institute for Alcohol and Drug Studies; and chairperson, Evansville Coalition for Nursing and Evansville Consortium for Nursing Continuing Education. Dr. Coudret is a graduate of St. Mary's Hospital School of Nursing and

received her B.S., M.A., and M.S.N. degrees from UE and an Ed.D. from Indiana University. She has been with the UE nursing program in various capacities since 1970, becoming dean of the nursing school in 1986.

Dr. Rice also announced two administrative appointments in the Office of Academic Affairs. Dr. M. Edward Jones will become associate vice president and director of extended services and Dr. Sandra M. Singer will become assistant vice president and director of graduate studies. Dr. Jones is now director of Continuing Education and General Studies, coming to USI in 1974 from Northwestern University where he was assistant dean. He received his B.S. from Brescia College and his M.S. and Ed.D. from Indiana University. Dr. Singer is the first director of the Evansville Graduate Studies Center and a USI associate professor of psychology. She received her B.A., M.A., and Ph.D. from the University of Colorado at Boulder where she was research administrator for the Institute for Behavorial Genetics prior to joining the USI faculty in 1980. Deans for the School of Business and the School of Education and Human Services will be named soon.

### ALUMNI ASSOCIATION HONORS FOUR WITH ANNUAL AWARDS

The Alumni Association presented four awards at the Annual Dinner-Dance April 23. Special Recognition Awards were presented to Michael Pugh and posthumously to Albert A. Woll for achievements in their careers and service to USI. The association honored 1972 graduate Frank F. McDonald II with the Distinguished Alumni Award and recognized Dr. Marlene Shaw, associate professor of biology, with the Faculty Recognition Award.


Michael Pugh attended USI from 1970 to 1972 and studied art and communications. A native of Indiana, Pugh lives in Marietta, Georgia, where he operates Michael Pugh Photography. A nationally known photographer, he most recently photographed the medal winners of the 1988 Winter Olympics in Calgary for Federal Express Corporation. From 1974 to 1983, he was an

international photographer for United Press International. Among his UPI assignments were the Apollo-Soyuz space mission, 1975 Pan American Games in Mexico City, the 1976 Olympic Games in Montreal, the NCAA Final Four, Super Bowls X and XIII, the Masters Golf championships, and the first and second launches of the Space Shuttle Columbia and the landing of the second at Edwards Air Force Base. He also covered activities of three U.S. Presidents — Jimmy Carter, Gerald Ford, and Ronald Reagan.

Former Trustee Albert A. Woll, who died 1987, made many contributions to USI's development. A long-time friend of education, he not only served on governing boards, but also enrolled regularly in USI classes. Woll was a native of New York City and came to Evansville to live in 1951. As head of Woll Enterprises, Inc., he was an independent oil producer and farm manager. He was a member of the Evansville-Vanderburgh School Board from 1959 to 1971, serving as president for two terms.




He was appointed in 1976 to the Indiana State University Board of Trustees and became a champion in the drive to establish a separate state university in Evansville. When that occurred in 1985, he resigned from the ISU Board and Governor Robert D. Orr made him an honorary member of the USI Board. Frank McDonald II was inaugurated as mayor of the City of Evansville in January, following in the footsteps of his father, who in 1965 was a key figure in the establishment of the state university campus in Evansville that became USI. The younger McDonald was a member of the second graduating class of the University. He entered the field of banking in Indianapolis, and returned to Evansville in 1976. He was with National City Bank several years, then joined Peoples Savings Bank where he was assistant vice president for commerical loans prior to becoming the mayor. A former member of City Council, he also had served as acting city controller, and as a member of the City Utility Board.

Dr. Marlene Shaw has been responsible for developing the "Biology at the Interface" lecture series at USI. Funded by both the GTE Foundation and Mead Johnson Foundation, the series has brought prominent scholars to USI to present public policy ideas about science, ethics, and law. Dr. Shaw has been at USI since 1973. She spent her 1983-84 sabbatical as a visiting scholar in molecular biology at Vanderbilt University and also has been an adjunct associate professor in medical genetics at the Evansville Center of the IU School of Medicine. Dr. Shaw is a sought-after mentor to students in science because she teaches valuable research skills and prepares her students for the demands of graduate and professional schools. Dr. Shaw has been invited to participate in the most selective of national research seminars, including "Medical Genetics: 1987" at the National Institutes of Health in Maryland; "Short Course in Medical and Experimental Mammalian Genetics" (1986) presented by Johns Hopkins University School of Medicine and the Jackson Laboratory at Bar Habor, Maine; and "Molecular Neurobiology of Human Disease" (1986) presented at Cold Spring Harbor Laboratory in New York.




