In the past few years, the University of Southern Indiana community has undergone some significant changes, some of them better publicized than others. We all cheered when our University gained its separation and we marveled at the enrollment increases when student housing became available, but some of you may not have been aware of another very important change happening during that same time.

Just as the administration, faculty, and supporters of the University were campaigning to carve out a new identity for our institution, the Alumni Council, as the governing body of the Alumni Association, was struggling to do the same for itself and the Alumni it represents. Hours-long Council meetings, weekend retreats, countless committee meetings, and finally, a revision of the constitution culminated in an expanded, more representative Council of 21 men and women from a variety of professions; a streamlined, more focused committee structure; and a concise, long-range mission statement for the Council.

As USI Alumni achieve an ever-broadening range of community involvement and professional accomplishment, the Council members saw the need to expand the Association's range of influence and activity and to reach out to a broader cross section of its membership.

To accomplish this, we are developing better and more frequent communications with our Alumni (the "new" 8600 is a good example) and planning educational, enrichment, and recreational programs and activities for our Alumni and their families.

We will continue to offer an increasing number of scholarships and grants to deserving students of every type and discipline, to sponsor the banquets and receptions we've all enjoyed, and in general, to support the University most effectively, in whatever manner we can. This means, of course, that fund raising will remain an important part (but never **the** most important part) of our effort.

I think that's the point I'd like to close with. During the four or more years you spent here as a student, USI's responsibility was to make available the best educational opportunities possible. Your responsibility as a student was to make the most of those opportunities.

Now, the institutional responsibility shifts to the Alumni Association to provide avenues for you, as Alumni, to grow personally and professionally and to interact with other Alumni, but the responsibility of participation still lies with you. We need you, not just to send us your contributions, but also to help us with programs involving student recruitment, new-graduate and Alumni job placement, and maintaining contact with out-of-town Alumni, to name a few.

The most important contribution you can make is to promote USI wherever and whenever you have the opportunity. The support of the Evansville community made USI what it is today, but it is the support of the USI community that can shape USI into the seat of higher education that will meet the educational and professional needs of southern Indiana for the years to come.

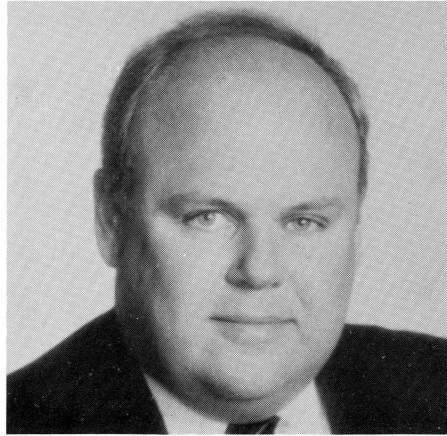

Morris Praises Community for USI Progress MORE THAN 500 GRADUATE IN CLASS OF 1987

More than 500 students graduated from the University of Southern Indiana in the Class of 1987. Commencement was held Saturday, May 9.

James T. Morris, president of the Lilly Endowment, Inc., in Indianapolis, delivered the 1987 Commencement address and received an honorary Doctor of Laws degree in recognition of his efforts to achieve excellence in education. Mr. Morris joined the Indianapolis philanthropy as director of community development programs in 1973 and became president in 1984. Through his work in community development, he has helped formulate plans and projects for the revitalization of Indianapolis. He also has an abiding interest in creating opportunities for youth and providing quality education in Indiana. In 1986, he announced that the Endowment would step up its efforts to improve education throughout the State. Since then, the Endowment has launched a series of statewide grants, including the largest grant program in Endowment history, a \$50-million scholarship fund for Indiana residents attending private and public colleges and universities in Indiana.

A native of Terre Haute, Mr. Morris was graduated from Garfield High School. He earned a bachelor's degree in political science from Indiana University in 1965 and a master's degree in business administration from Butler University in 1970. For eight years, he served on the Board of Trustees of Indiana State University and was board chairman for two years. He also is a member of the Executive Board of the U.S. Olympic Committee for the Pan American Games to be held in Indianapolis this summer. In 1970-71, Mr. Morris was a member of the U.S. delegation to NATO's committee on the Challenges of Modern Society.

In his Commencement address, Mr. Morris stressed the importance of education to the future of America. He said that public education "is what has made America different, and that "the fact that universal, high quality, public education has been

accessible for young people from kindergarten through college has prepared America to share the dreams of success and participation for every citizen." He challenged the graduates to value education, saying, "There is no more important crusade to which any of us can commit ourselves than preserving this opportunity and strengthening it."

Mr. Morris complimented the southern Indiana community for its achievements in strengthening education through the establishment of USI. "This is one of the most impressive and positive university experiences in American higher education today," he declared, as he related how the campus first was established and matured to a separate state university. Mr. Morris said the evolution of USI "is the best example I know of our ability to realize big dreams working together in our own back yards."

Other honorary degrees conferred were a Doctor of Letters degree for Gail Lumet Buckley, author of *The Hornes: An American Family*, and a Doctor of Science degree for Kenneth Dale Owen, descendant of the pioneering Owen family of New Harmony and a geologist who helped develop the oil industry in Texas. He was recognized for his contributions to business and historic preservation.

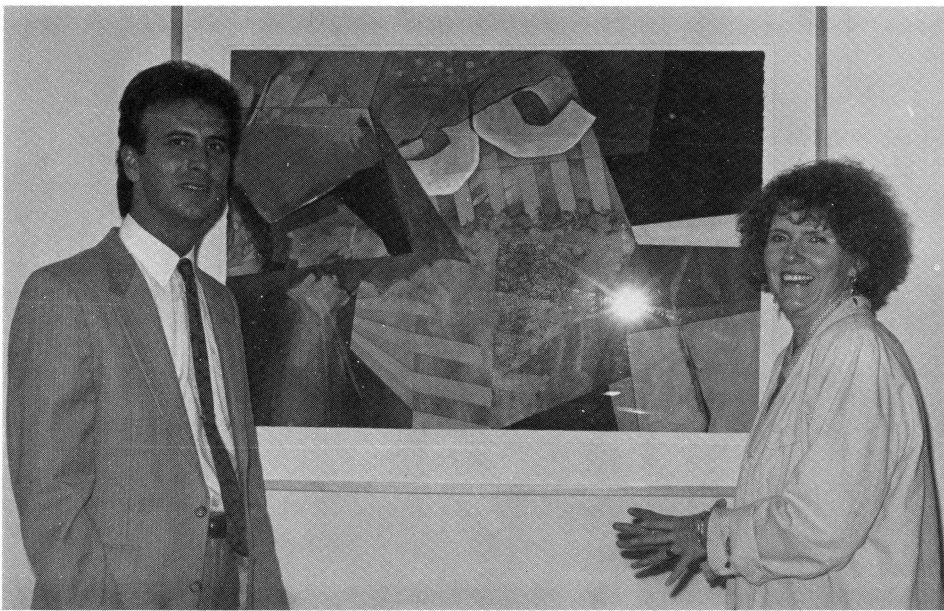
Mrs. Buckley's book tells the story of her forebears, one of whom was Edwin Horne, her great-grandfather who grew up in Evansville, and includes a glimpse into the life of her mother, famed singer Lena Horne, who became the first black movie star of international acclaim. Mrs. Buckley is a 1959 graduate of Radcliffe College who worked for Marie-Claire magazine in Paris and for Life magazine. She expects to develop a sequel to her book with material that had to be left out of the

original book. Mrs. Buckley was recognized for her contribution to American literature through a work that touches on the history of Evansville in the city's 175th anniversary year.

Mr. Owen was born in New Harmony in 1903, the son of Lucille Eagle, granddaughter of Pierre Duclos, and Richard Dale Owen, great-grandson of Robert Owen, who established an intellectual and utopian community in New Harmony in 1824. Mr. Owen earned an A.B. degree in geology at Cornell University and worked as a field geologist in Texas during the 1920s, when the oil industry was beginning to use scientific tools in exploration. By combining his expertise with that of two geophysicists, he was able to discover a highly productive oil field that became the financial basis of his formation of two successful companies, Gulfshore Oil Company and Trans-Tex Production Company. Mr. Owen and his wife, the

former Miss Jane Blaffer of Houston, have retained an active interest in the restoration and preservation of properties in New Harmony, where he is vice chairman of the New Harmony Commission. He also is one of the seven founding members of the New Lanark Association, Ltd., in Scotland, an organization restoring the original Owen industrial properties which Robert Owen left when he came to America and New Harmony in 1824.

Carma A. Hoffman of 1441 Greene Street, Jasper, Indiana, an elementary education major, was graduated summa cum laude with a perfect 4.00 grade point average. Twenty-two students were graduated magna cum laude, having a scholarship index of 3.80 or higher. Another 26 students with grade point averages ranging from 3.60 to 3.80 were graduated cum laude.

USI ARTISTS REUNITED AT NEW HARMONY

It was a time for old friends to catch up on the last few years and to see which direction each other's creativity was taking in their respective art forms. The opening reception for the New Harmony Gallery of Contemporary Art's "USI Alumni Invitational" show was a grand reunion of former USI art students, their mentors, long-lost friends, and long-time admirers.

The works of the five USI alumni were displayed April 5-29. Chosen by the faculty at USI, the artists represented were Margie Marx, Dennis R. Montgomery, Christine Reising, Don "Scooby" Ledbetter, and Lysa Howard-McDowell. The latter, now a California resident, was the only artist unable to attend the reception-reunion.

Two of the featured artists exhibited several sculptured pieces. Ledbetter, a 1984 USI graduate, and Montgomery, a 1985 grad, are both Evansville natives who went on to advanced studies in the field of sculpture. Ledbetter received a masters degree in May from Clemson University, South Carolina, and Montgomery is in the graduate program at Southern Illinois University at Edwardsville.

Ledbetter's most unusual piece, entitled "Kiss This," drew a lot of attention from guests. The artwork was made using a broken piece of the marble altar that once occupied St. Joseph Catholic Church in Evansville. "I found this beautiful altar piece in a junkyard all covered with weeds. It was mostly sacrilegious to me that something so revered and mystical was thrown on the heap. Bishops have kissed this altar in reverence and here it was thrown aside," the young artist explained. Since Catholic altars contain the relics of dead saints within them,

Ledbetter made his own version of "relics" in his altar piece. Three of his wisdom teeth are on display under the glass.

A work by Montgomery, called "Waiting for the Kill," was a real crowd pleaser. The metallic sculpture depicts a vulture perched and ready, awaiting some dead dinner. "Did you know it was kinetic?" the artist obligingly asked as he gave the raptor sculpture a spin.

Montgomery describes another piece, fashioned from metal and wood, "The State of Coloring Ado," as "just a basic mountain scape." The artist said he explores space and form with the use of geometric concepts and angles, a knowledge gained from his surveying experience.

Evansville native Margie Marx graduated from USI in 1979 and received a Master of Art from Purdue University in 1982. The Lafayette resident has several colorful collages on display in the show. The colors in her work are bold, bright, and vivid. "I used to work in pastels, but just recently started doing collages with intense colors and more black in them," she said. "My imagery is also getting more abstract. I use imagery a lot and feel each work is like a page in the book of my life."

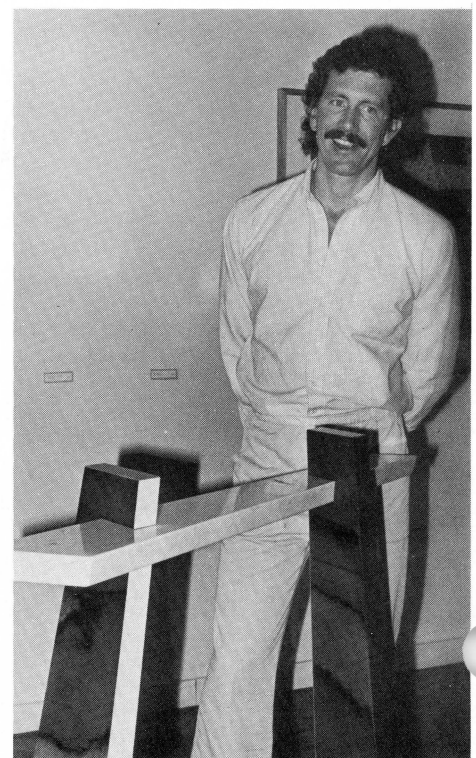
Miss Marx noted how some pieces might have a sense of feelings. "These long red lines symbolize yelling to me, these circles are talk, and these C shapes stand for life forms, like myself," she pointed out. "All of these varied patterned areas remind me of different friends and their different environments."

Christine Reising, a native of Detroit, graduated from USI in 1979 and obtained a Master of Fine Arts degree from the University of Windsor, Canada, in 1981. She exhibited several pieces from a two-year collaboration with poet Margo LaGuttutta, called "noedgelines," in the Gallery show. "Even though the two of us worked separately, it was interesting how our work connected. My art and her poems really went together," she said. One interesting piece, a drawing called "Eraser Fish," features humorous axioms Margo typed up real fast one day as Christine wove them around her figure as a border.

Mrs. Reising, now an assistant professor at Siena Heights College in Adrian, Michigan, also has three unique artistic crutches on display. "I came up with the idea of a crutch while in grad school," she explained. "It was a personal thing; my son had to use one with a hip disease and I've just carried it from there. I love the shape of a crutch."

Now her crutches symbolize the things in life that are emotional "crutches" for people: fear, rejection, and jealousy. The jealousy crutch is a fascinating mixture of a dangling eraser, broken mirrors, her grandmother's brooch, a sentimental leg from a baby doll, plastic beads and roses, peacock feathers, and washers from her husband's toolbox. The fear crutch is painted a foreboding black color while the dependency crutch is a mixture of rice paper, foam, and sticks.

Lysa Howard-McDowell is a 1984 graduate and resides in California where she is a book designer and the production manager for Story Line Press. Her drawings employ grids or the use of objects within compartmentalized spaces.

ON CAMPUS

PLANNING IS STARTED FOR CLASSROOM BUILDING

Funding approval for USI's \$7.8-million classroom building was achieved during the waning hours of the 1987 Indiana General Assembly. Subsequently, the USI Board of Trustees authorized University President David L. Rice to request approvals from the Indiana Commission for Higher Education, the State Budget Committee, and Governor Robert D. Orr that would allow University officials to proceed with arranging financing; engaging Odle/Burke Architects of Bloomington, Indiana, to develop final plans; and entering into construction contracts. Construction of the building — to be located adjacent to the Administration Building and house classrooms, faculty offices, and centralized student services — is expected to begin in the spring of 1988 and be completed in the fall of 1989.

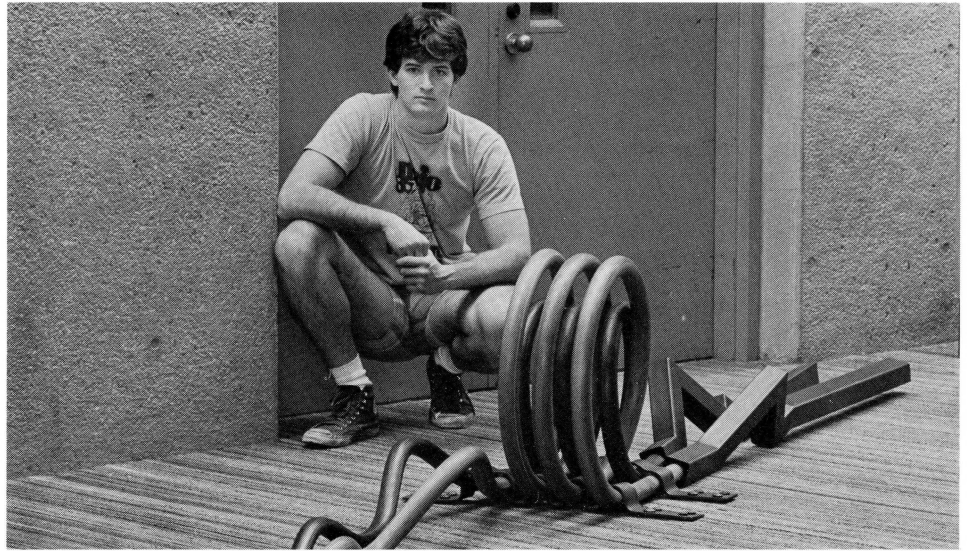

NEARLY 5,000 VIEW MAGNA CARTA AT USI

A total of 4,852 persons — nearly 1,000 of them school children from the Tri-State — toured the "Roads to Liberty: Magna Carta to the Constitution" exhibit at USI in late April. Included were the more than 200 persons who attended a breakfast at the University Center, sponsored by USI and the Evansville Bar Association as the official opening event for the exhibit.

"Roads to Liberty" is a major exhibit of rare and historic documents, including the 772-year-old Magna Carta that is one of only four copies still in existence, the 1787 Pierce-Butler draft of the U.S. Constitution, and an original Declaration of Independence broadside. Documents significant in Indiana history were included during the two stops the exhibit made in the state, ending its tour of Northwest Territory states. The exhibition will be on tour in the original 13 states, starting in June, and is a joint project of the Commission on the Bicentennial of the U. S. Constitution, the U. S. Constitution Council of the Thirteen Original States, and American Express Company.

ALUMNI ASSOCIATION HONORS TWO GRADUATES WHO ESTABLISHED \$10,000 SCHOLARSHIP ENDOWMENTS

Two University of Southern Indiana graduates who each recently established a \$10,000 scholarship endowment at USI were presented the USI Alumni Association's 1987 Distinguished Alumni Award at the annual banquet April 25.

The endowments — the first to be presented to the University by graduates — were established by O. John Logsdon to aid chemistry students and by Suzanne Schnacke to aid students enrolled in allied health fields. Ms. Schnacke's endowment is a memorial to her father, Bernard Schnacke, an Evansville business and civic leader who died in 1986. He was a long-time friend of the University.

Mr. Logsdon, a 1973 chemistry graduate, was employed after graduation as a chemist with the Environmental Protection Agency, then became manager of mass spectrometry at EPA's National Enforcement Investigation Center. In 1980, he co-founded and was manager of the Rocky Mountain Analytical Lab, a lab that provides chemical analysis of environmental samples. Last year, his company merged with Enseco Information Services, headquartered at Arvada, Colorado. He now is vice president for information services at Enseco.

Ms. Schnacke, a 1975 dental assisting graduate who is supervisor and instructor at USI, was a member of the original Dental Advisory Committee that helped to establish the dental assisting and dental hygiene programs at the University. She is a past

president of the Evansville Dental Assistants Society and the Indiana, Illinois, and Michigan division of the American Dental Assistants Association; is a test writer for the Dental Assisting National Board of Certification Examination; and is an editor and co-author of a comprehensive dental assisting textbook to be published by C. V. Mosby Company.

The Alumni Association also recognized Governor Robert D. Orr and history Professor Darrel Bigham for their contributions to the University and to education.

The association's Special Recognition Award was presented to Governor Orr for his leadership in mak-

ing USI Indiana's sixth state university and for education in general in Indiana. The Faculty Recognition Award was presented to Dr. Bigham for "contributions to teaching, scholarship, and service to the community and the academy," and includes presentation of a scholarship in his name at the 1988 Honors Day program.

In the association's annual meeting prior to the dinner, Tina Alcorn Kern, a 1983 graduate who is a personal computer support specialist at Keller-Crescent Company, was elected new association president. Other new officers are Robert W. Swan ('72), vice president; Ronda Cutteridge Hall ('83), secretary; and David T. Raibley ('73), treasurer.



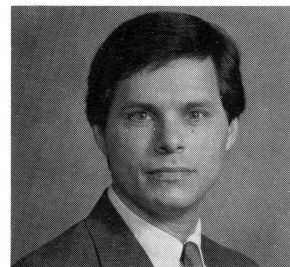
KARCH GIFT ENDOWS SCHOLARSHIP FUND

1972 GRADUATE FRANK McDONALD II BECOMES MAYOR OF EVANSVILLE



Frank McDonald II, a 1972 management graduate of USI, was elected mayor of Evansville on May 23 to complete the term of Michael D. Vandevener, who resigned as mayor to become a lobbyist with Bristol-Myers.

McDonald is the son of former three-term Evansville Mayor Frank McDonald, a USI Foundation Board member and one of the key persons instrumental in creating the Indiana State University-Evansville branch campus in 1965 that became the University of Southern Indiana on July 1, 1985.

The younger McDonald, a 1969 graduate of Evansville Bosse High School, was a member of the second class to graduate from the university. He first

worked for Merchants National Bank & Trust of Indianapolis, returning to Evansville in 1976 to become affiliated with National City Bank. On January 1, 1985, he became assistant vice president for commercial loans at Peoples Savings Bank.

Although McDonald had become increasingly more involved in Democratic politics in Evansville, it was a unique series of events that made him the city's 31st mayor without having gone through a general election.

He was elected by Democratic precinct committeemen to an at-large City Council seat in 1986, to complete the term of Jerry Linzy, and was a candidate this year for his first full term on the council. When Vandevener announced his resignation in early May, McDonald immediately became the leading candidate to be Vandevener's successor and was elected by the Democratic committeemen by acclamation. He remains a candidate in the 1987 city election, now for mayor, not City Council.

During Vandevener's tenure, McDonald was acting city controller for six months in 1983 and also was a member of the city Utility Board for five years, resigning that post when he was elected to City Council.

McDonald and his wife, Nancy, have two sons, Mitchell and Marshall.
