

### Donor Recognition Program at \$120,000 Construction of University Center Continues


The Donor Recognition Program, which was initiated by the Evansville Campus Foundation to equip the new University Center and duly recognize the benefactors, has raised over \$120,000.00 to date. Fifty individuals, families and companies have participated in the Donor Recognition Program with most of the rooms now being furnished. Opportunities to participate in the Donor Recognition Program still remain open, however, and interested families or individuals are welcome to contact the ISUE Foundation Office for further details

A gala opening of the new building is planned for spring. Donor Recognition Program participants will be invited to the opening to see their individual rooms and celebrate the opening of this much needed campus building.

Construction of the University Center has reached the upper level of the tri-level building and work on the connecting structure to the Library, the Continuing Education Wing, continues.

The Continuing Education Wing will provide multi-purpose rooms for continuing education instruction by way of the state-wide educational television network, IHETS; conference rooms; and a place for formal receptions and teas. The space will be developed so that it can be opened into one large room or divided by foldings doors into four multi-purpose rooms.

The University Center, designed as a focal point on campus, will provide space for student organization work areas; conference rooms; lounge facilities, a grill area, a recreation area, a formal dining area, and the University Bookstore.

#### **ALUMNI ROOM**

The ISUE Alumni Association accepted the challenge to participate in the Donor Recognition Program of the ISUE Foundation with a pledge of \$3,000. The funds will be used to furnish an Alumni Room in the Presidents Suite on the second level of the University Center. The larger Presidents Suite is divided into two rooms, one of which will be the Alumni Room and the other the Presidents Room. Each room can accommodate 30 persons. The entire area of the Presidents Suite can be opened when larger facilities are needed to accommodate an event.

The Alumni Room, as well as the total University Center, will be furnished in modern decor. The Alumni Room will have natural wood tables and polished chrome tubular steel sling chairs. The carpet will be brown. Oak beams will be featured in the ceiling.

## TEACHER EDUCATION NCATE APPROVED

The Education Division at Indiana State University Evansville has received initial accreditation of the teacher education program from the National Council for Accreditation of Teacher Education (NCATE).

NCATE accreditation is the second separate national accreditation the Evansville Campus has received for academic programs. The dental hygiene and dental assisting programs have received provisional approval from the American Dental Association. According to Education Division Chairman Ted DeVries. the accreditation is very important to a campus. "NCATE accreditation is the blueribbon accreditation in teacher education. It means leaders in the profession have examined our teacher education program and found it a quality program." A seven person examining board toured the facilities and interviewed faculty and students last March

In further explanation of the NCATE accreditation and exactly what it means, Dr. DeVries feels the approval illustrates that Indiana State University Evansville is a rapidly maturing institution with outstanding faculty.

The accreditation also means benefits for the student in the ISUE teacher education program. According to DeVries, "it will be possible for our graduates to teach in other states. Through NCATE a teacher license has reciprocity with other states. Students graduating from an NCATE accredited school can more easily enter graduate school. And the accreditation is a good basis for building other programs in teacher education."

The teacher education program at Indiana State University Evansville has departed from traditional teacher education programs. The NCATE accreditation lauds the new direction.




The transportation includes round trip air from Evansville to Chicago to Honolulu.





# President Reports ISUE FOUNDATION MERITS

During the Foundation Board of Directors annual fall meeting, the President of the Foundation, Joseph O'Daniel, addressed the Board as to the merits of the ISUE Foundation. Excerpts from his address follow.

Foundation are self-evident. With assets totaling \$175,000 the ISUE Foundation begins its fifth year of service to Indiana State University Evansville. The ISUE Foundation has undertaken four major programs to raise funds to cover activities important to a developing institution.

"The first project the ISUE Foundation developed was the Century Club. The Century Club was to be composed of donors who contribute \$100 annually for unrestricted funds. The Century Club began in the fall of 1969 with 21 charter members. These charter members were each asked to encourage a friend to join the Century Club. E. Donald Elliott was named chairman of the Century Club project that year and he has served most ably in that position. The February 1970 Century Club roster listed 77 persons who accepted the invitation from Mr. Elliott to aid ISUE in its guest to provide higher education opportunities in the best manner possible to the Tri-State area residents.

"The roster of Century Club members continued to grow with 116 in December 1970; 144 in December 1971; and 200 in December 1972. Enrollment in Century Club at the present time is nearing 250.


"Funds from the Century Club are used to provide scholarship programs, development money for the Mid-America Singers, faculty research, and campus hospitality. "The Book Club project was established in February 1970 to furnish funds to equip the University Library. Through efforts of Evansville Jaycees and ISUE student organizations over \$4,500 was raised in the first month of the campaign. The Book Club is a thriving project that is used especially for "in memoriam" contributions. A book label enscribed with the donor's name is attached to a book for each \$10.00 contributed. Nearly 500 donors have participated in the Book Club.

"The Dental Education Fund was an ISUE Foundation sponsored project to raise funds for the development of dental education facilities. Local dentists were canvassed as potential donors, and all participants who contributed \$200 or more were listed on a recognition plaque that hangs in the dental clinic at ISUE.

"The Donor Recognition Program, the fourth project of the Foundation, was established for promoting interest in financing a room or equipping an office in the University Center with appropriate recognition given to the donors. Donations to the Donor Recognition Program range from \$1600 to \$10,000. Current total for University Center Donor Recognition Program is over \$120,000.00.

"Another fund-raising project, the Screaming Eagles Varsity Club, has come under the auspices of the ISUE Foundation. The Screaming Eagles Varsity Club began as a dream of Mr. Elmer Sander, then Director of Financial Aids at ISUE, who retired last year. He saw the Varsity Club as means to raise funds to support athletic programs at the campus. The Varsity Club began in 1971 and

current enrollment in the Varsity Club includes 26 Golden Eagles (persons giving \$100 or more) and 100 other members. The Varsity Club's main purpose is to attract athletic talent to the campus through scholarship support.

"We all remember the Campus Recognition Program held by the Chamber of Commerce and the theme of that day that previous accomplishments are but a whisper of things to come. As I give my report today, we recognize our attainments as a whisper of things to come for our Foundation.

"It has been a rewarding and pleasant experience for me to work with this dis-

tinguished Board during this four years. Please know that I appreciate your support and cooperation.

"The accomplishments of these past four years are adequate evidence that we are blessed with an abundance of leadership talent. A broad base of support and depth in leadership is essential to the continued success of the Foundation and the development of the Evansville Campus. This can best be maintained by spreading the responsibility of leadership and avoiding a concentration for extended periods of time. Of all the activities in which I am or have been involved I find the ISUE Foundation and development work most pleasant and meaningful and I sincerely hope I can continue to serve and enjoy this association for a long time but it should be as one of you rather than as your president. It is time to recognize other talents and spread the responsibility of leadership."

Mr. O'Daniel served as the first President of the ISUE Foundation. He has served in that capacity since 1969.

#### STUDY IN MEXICO

Indiana State University Evansville is offering a course in language, culture, and literature of Mexico in San Luis Potosi, Mexico in 1974. Students may earn a maximum of six semester hours credit, graduate or undergraduate. The course will begin July 17 and continue through August 20, 1974.

Planned side trips include excursions to Ciudad de Mexico (Mexico City) and Guadalajara.

The cost will be approximately \$450, which includes air fare from Laredo, Texas, to San Luis and return to Laredo; all tuition fees; full board and lodging at San Luis; and bus fare and hotel from trips in Mexico. Participants must provide for their own meals during trips, their transportation from home to Laredo and back, and books, passport and personal expenses.

First payment of \$150 must be made by February 15, 1974 to insure reservations.


Late registration will begin January 10 and schedule revision begins January 14.

## CITY SEWER TAP-IN APPROVED

Senator Harry E. Thompson was notified by the Chairman of the Senate Finance Committee, Senator Larry Borst, that the State Budget Committee has approved the release of funds for Indiana State University Evansville to enter into a contract with the Board of Public Works of the City of Evansville to connect the campus sewer network to the Schutte Road Lateral of the Carpenter Creek Sewer System. Indiana State University Evansville will pay a \$220,000 tap-in fee. The project was also approved by the Indiana Commission for Higher Education.

Indiana State University Evansville currently operates its own sewage treatment facilities. The Indiana Stream Pollution Control Board in 1968 gave preliminary approval to the plant

providing that the facilities be abandoned and a connection be made to the Evansville sanitary sewer system when it became available.

"This tap-in with the Evansville sanitary sewer system comes at a most important time", according to ISUE President David Rice. "If the Evansville sanitary sewer system were not available, it would be necessary to construct additional sewage treatment facilities to up-grade the facilities to current standards"







# RAMSDEN DIRECTS VETERANS AFFAIRS

Indiana State University Evansville recently established an Office of Veterans Affairs through a grant made possible by the federal government. Donald Ramsden was appointed Director of Veterans Affairs. He is assisted by a secretary, several peer group counselors, and outreach worker-counselors.

The function of the Office of Veterans Affairs is basically three-fold. The first is a counseling function. A strong liason with community counseling resources will be developed and maintained to assist all veterans. In addition, peer group counselors will be utilized to provide veterans with information on VA educational benefits, remedial and special education programs, and referrals to various agencies such as Veterans Administration, Legal Aid, American Red Cross, drug dependency units, medical assistance and job employment agencies, and other agencies that could provide supportive services for the veteran.

The second function is the one concerned with special education programs including remedial, tutorial, and motivational programs which are designed to insure success at ISUE.

Finally, the outreach function is an extensive community wide program of reaching veterans, determining their needs and making appropriate referral and follow-up arrangements with relevant service agencies. Persons are encouraged to contact Mr. Ramsden to discuss veterans needs, problems, or to offer suggestions related to veterans problems.

### RUSTIC LODGE RESTORED

A log lodge on a southeast portion of the campus has been restored by Westwood Garden Club. The Westwood Lodge, sonamed by ISUE President David Rice in recognition of the work of the members of the Garden Club, is a rustic meeting place for scout troops, science and biology teachers and their classes on field trips, or any group that enjoys the outdoors.

Westwood Lodge is situated on top of a bluff adjoining a natural amphitheater. The bluff and cave-like depressions in the surrounding woods lend a beautiful setting to the lodge.

In May 1971 Westwood Garden Club had won top prize in a nationwide environmental improvement program co-sponsored by the National Council of State Garden Clubs and Sears Roebuck Co. The project was development of an outdoor learning environment on the ISUE campus. The project was named Bent Twig Outdoor Learning Environment and consisted of 25 acres of foot trails and vistas overlooking a 7½ acre lake. Along with top prize honors the Club received \$2500 in prize money. With the prize money as a base, and various fund raising ventures, the club voted to restore the log lodge.

The lodge was a summer home of the James McCarty family in the 1940's. Mrs. McCarty states that 100 year old hand hewed logs from an original pioneer barn were used to construct the lodge.

Westwood Lodge has one main room with a fireplace, an enclosed porch, and an outdoor patio. The lodge accommodates between 45 and 60 persons.

Another log structure located about 100 yards from Westwood Lodge is being restored by the Garden Club and twenty-four students in an intermediate carpenter class from the Breckenridge Job Corps Center in Morganfield, Kentucky.

This second rennovation project is part of the total plan to restore the log buildings on the campus undertaken by Westwood Garden Club. The lodge when completed can be used for field trips, scout meetings, and as an overnight camping facility.

Marshall Arnold, instructor in the carpenter class and supervisor of the project, explained that the corpsmen are using the project for a laboratory training program.


