USI Board of Trustees approves 2001-2003 capital improvement budget request, schematic plans and cost estimates for science/education classroom building

At the regular meeting of USI Board of Trustees held on campus July 13, the board approved the capital improvement budget request for the 2001-03 biennium amounting to over \$37.7 million in capital improvements.

The request includes the proposal to complete funding of a science/education classroom building, expand the David L. Rice Library, and make improvements to campus roadways.

The University's number one capital priority is funding for completion of the science/education classroom building. The 1999 General Assembly approved \$12.6 million of bonding authority for Phase I of the project. USI seeks Phase II support in the amount of \$10.5 million to complete construction of the facility that is to provide general and specialized classrooms, computer, multi-media, and teaching research laboratories for the Pott School of Science and Engineering Technology and the Bower-Suhrheinrich School of Education and Human Services, plus academic instructional support areas for University Division Advising and Academic Skills.

Expansion of Rice Library is the number two capital priority. The funding request of \$23.2 million will provide additional library space, general-purpose classrooms, programming and office space for Academic Affairs, and additional space for Central Stores and Distribution Services. Rice Library opened in 1971 to serve a maximum of 5,000 students; the University has outgrown the facility by almost 4,000 students. Expansion will allow the library to increase service and integrate additional technology into the facility.

The third priority is for special repair and rehabilitation funds for Phase I of the campus entrance/roadway relocation **project.** This safety-related project will improve the intersection and flow of traffic at the University's main entrance and primary roadway. Estimated cost is \$4 million.

In other business, architects from the firms of Edmund L. Hafer and Associates and Hastings and Chivetta presented plans and cost estimates for the Science/Education Classroom Building.


The architects set initial cost estimates at \$22.3 million for the classroom, but said further work is being done to cut that cost to match the proposed bonding request of \$21.6 million.

In other business, the board reviewed the preliminary figures for the biennial operating budget appropriation request of approximately \$33.5 million in 2001-02 and \$36.5 million in 2002-03. The request will carry quality improvement initiatives to develop new degree programs and strengthen the undergraduate experience through instructional support services, student retention initiatives, and expansion of faculty resources.

The request also will include a four percent increase for personal services and benefits, a three percent increase for supplies and expenses, plant expansion, and a three percent base adjustment for prior enrollments.

The board approved honorary doctorate degrees for Donald R. Hazeltine, a long-time member of the Board of Directors and Advisory Council of the USI Foundation, and his wife Allene, who assisted in the development of student life programs in the early years of the campus. The degrees will be awarded on August 24 during the President's Associates Dinner on campus.

USI graduate's sculpture wins bronze medal

A sculpture by USI graduate and Indiana artist Megan Russell, the only entry from the United States selected in international competition, will be one of 16 sculptures to be presented in the Cultural Program during the XXVII Olympic Games in Sydney, Australia, in September. Ms. Russell's sculpture competed with 68 pieces from 54 countries after winning a bronze medal in the U.S. Olympic Committee's Sport Art Competition.

The only entry from the United States selected in international competition, the sculpture, entitled "Frustration," is a tennis racket carved from ash with a handle of a dark wood called wenge and strings of wood filament.

Ms. Russell submitted the sculpture to the USOC Sport Art Competition 2000 and was notified in March that she was a bronze medallist in the sculpture division. The sculpture was submitted in the next level of competition at the International Olympic Committee Museum in Lausanne, Switzerland, and was named one of 16 winners.

Ms. Russell entered the racket along with sculptures of a soccer ball and baseball bat as a collection she called "Hot Competition." The three pieces appear to be melting. She said her inspiration was the idea that the Olympics are, indeed, hot competitions. She focused her interpretation on the summer heat and the idea of the heated battle in the Summer Olympics.

The Cultural Commission of the International Olympic Committee (IOC) launched the Olympic Art and Sport Contest as part of the celebration the IOC is organizing for the new millennium. National Olympic Committees in 54 countries accepted the invitation to participate and the U.S. contest was open to American citizens of all ages. The participants had to be art students or athletes affiliated with an Olympic sport.



Russell concluded her intercollegiate athletic career at USI as a 1998 women's soccer National Soccer Coaches Association of America second team All-American, a three-time All-Region player, and a three-time All-Great Lakes Valley Conference performer. A team captain each of her four years, Russell helped lead USI to the NCAA Division II Tournament quarterfinal in 1998. She graduated with a baccalaureate degree in art in May 2000.

The Olympic Museum in Lausanne, Switzerland, plans to purchase the sculpture and will make it a permanent part of its world-famous collection.

Ms. Russell thanked Dr. Hilary Braysmith, the assistant professor of art who told her about the Olympic Art and Sport Contest and Mr. John McNaughton, the art professor who supported and encouraged her entry.

The U.S. competition was hosted by The American Sport Art Museum and Archives (ASAMA) of the United States Sports Academy. Results of the competition including the Russell sculpture are displayed in the visual gallery at www.museum.olympic.org.
