### **Westbrook to coach USI men's team**

The USI Athletic Department has announced the hiring of Mr. Scott Westbrook, a University of Evansville graduate and former UE soccer standout, as head coach for men's soccer.

Mr. Westbrook, who has a 104-83-18 career record in ten seasons as a college head coach, began coaching in 1985 at Lindenwood College, St. Charles, Missouri, leading them to National Association of Intercollegiate Athletics (NAIA) playoffs in 1985 and 1987. He was named Show Me Conference Coach of the Year in 1987.

In 1989, Mr. Westbrook took over the soccer team at Fontbonne College, St. Louis. His squads went to post-season play in 1989, 1990, 1991, and 1992, and reached the NCAA Division II Regional finals in 1991 and 1992. He was named the St. Louis Intercollegiate Athletic Conference Coach of the Year in 1990, 1991, and 1992, and the Gatorade Mid-West Regional Coach of the Year in 1991.

Prior to coming to USI, Mr. Westbrook coached the University of Arkansas-Little Rock in 1994 and 1995 and was the assistant compliance coordinator at UA-LR.

Mr. Westbrook earned a bachelor's degree in psychology from UE in 1982 and a master of business administration from Fontbonne in 1994. He led the UE Aces to their first ever appearance in the NCAA Division I tournament, was named to the All-Mideast Region team, and was selected for the Senior Bowl in 1982. He played in indoor and outdoor leagues prior to entering coaching, and was selected 21st overall in the Major Indoor Soccer League (MISL) draft by the Wichita Wings in 1983 and later was Rookie of the Year for the Detroit Express of the American Soccer League (ASL).
