NEWS FORUM VIDEOTAPE AVAILABLE FROM IHETS. IHETS "News Forum, a co-operative effort of the sixteen campuses of Indiana's public universities, has available for classroom use a 50-minute videotape on the impact of the new federalism on Indiana.

In the May 25th forum, Judith Palmer, Director of the Indiana State Budget Agency, and Leonard Schneiderman, dean of the Indiana University School of Social Work in Indianapolis, dealt with the impact of the new federalism on financing of human services, including health, housing, employment and education. Schneiderman presents his view that the new federalism assigns responsibilities for the national welfare to the states, which they will not be able to meet effectively.

On the other hand, Palmer believes the new federalism will provide Indiana with greater flexibility to establish priorities for social programs at the state and local levels and eliminate duplication. Some other subjects explored in this news forum are the role of the federal and state government, trust in politicians, and economic development.

ADDITIONAL BENEFIT AVAILABLE TO BIWEEKLY STAFF. On July 1, 1982, the Group Disability Insurance program through the Teachers' Insurance and Annuity Association will be expanded to include coverage for eligible, full-time biweekly employees who have at least three years of continuous service with the University. The monthly premium for this additional benefit will be paid in full by the University.

The insurance program provides coverage in the event of long-term total disability. Benefits would begin on the first day of the month following six consecutive months of total disability and would continue during the months of such disability until age 65. During the period of disability, the individual would receive a monthly income benefit and continuation of retirement contributions to a TIAA/CREF annuity contract.

Staff members eligible for coverage effective July 1, 1982 will be receiving additional enrollment information. The Personnel Office will be contacting employees as they become eligible for coverage.

ISU FEDERAL CREDIT UNION. Dividends on share and club accounts are computed daily, from day of deposit to day of withdrawal. Even though dividends are computed daily, they are not paid into the accounts until the end of the quarter. Dividends paid on the last day of March, June, September and December are available for withdrawal on the first day of January, April, July and October. The dividend rate is set each quarter by the Board of Directors.
