SESSION #9 MINUTES OF THE 1983-84 FACULTY COUNCIL MEETINGS

The minutes were approved as amended.

2. Announcements

The next meeting of the Faculty Council will be Friday, February 10, 1984 at 3:00 p.m. in L-100.

3. Reports

The ISUE Independence Bill was passed yesterday in the Senate.

Vice President Reid announced that the Computer Advisory Committee on Curriculum has been working to clarify issues on computer science courses.

4. Curricular petitions

Professor Everett made a motion to accept CIS 251, Modern Computing Techniques. Professor Davis seconded the motion. Vice President Reid commented that the catalog description for this course should include the information that BASIC is the programming language. It was approved.

Professor Petranek made a motion to accept CIS 375, Systems Analysis and Design. Professor Everett seconded the motion. Professor Dunn questioned whether the Division had intended to not require math as a prerequisite. Vice President Reid said he would discuss this issue with Chairman Settle before approving the course. The motion passed.

Professor Everett made a motion to accept ED 151, Reading Power. Professor Swope seconded the motion. The motion passed.

Professor Petranek made a motion to accept ED 406, The Remediation of Learning Disabilities. Professor Everett seconded the motion. The motion passed.

Professor Everett made a motion to accept ETHS 270, General Astronomy. Professor Petranek seconded the motion. Vice President Reid requested the number be changed to a course number ending in a number other than 9 or 0, because it is a non-repeatable course. The motion passed.

Professor Everett made a motion to accept SOC 250, Introduction to Social Psycholog Professor Davis seconded the motion. Vice President Reid requested the number be changed to a course number ending in a number other than 9 or 0, because it is a non-repeatable course. Professor Petranek stated that the reason for the course modification was to change the number. There was a general discussion on the similarities between the Sociology Department's and the Psychology Department's courses both entitled "Introduction to Social Psychology". Professor Everett withdrew his motion with the approval of Professor Davis. After further general discussion, Professor Everett reintroduced his motion and Professor Davis seconded it. The motion passed 6 to 1.

Professor Everett made a motion to accept CS 141, Introduction to PASCAL. Professor Petranek seconded the motion. Professor Dunn questioned whether the course should be 3 rather than 2 hours. The motion passed.

Professor Everett made a motion to accept SOC 351, Mass Media in American Society. Professor Swope seconded the motion. The motion passed.

Professor Petranek made a motion to accept the request for a modification in the requirements for a major in Sociology, and the elimination of SOC 120 as a prerequisite for all other sociology courses. Professor Swope seconded it. A discussion followed. The motion failed 2 to 4. The course modification was returned to the Curricular Committee for study of the following issues:

1) sequence necessary for SOC 120 for sociology majors 2) possibility of prerequisite of "approval of instructor" 3) reason SOC 120 no longer necessary as a prerequisite 4) purpose of SOC 120.

5. Old Business

There was no old business.

6. New Business

Chairman Goss introduced the report by the Student Academic Affairs Committee on procedures to remove a student from class. Professor Sands, Chairperson of the Student Academic Affairs Committee, explained the procedures proposed by the committee. Time did not permit further discussion of some of the members questions.

7. Adjournment

The meeting was adjourned at 4:55 p.m.
