FACULTY COUNCIL MEETINGS

The meeting was called to order at 2:35 p.m.

1. Approval of the January 13, 1976, minutes.

The minutes of the January 13, 1976, Faculty Council meeting were approved.

2. Request from David Deering.

David Deering and Ralph Kent asked for Faculty Council approval of a voluntary program in which faculty members would donate unsolicited desk copies of textbooks to the Alumni Association and/or the Wallace Wardner Fund. Monies derived from the sale of these donated books would be used for scholarships.

Professor Marr moved

that "we endorse this program."

Professor Scavone seconded the motion.
