**NORTH CENTRAL SELF-STUDY.** Progress on this important aspect of the university's development was reviewed at a recent meeting of the Academic Planning Council. All academic divisions are nearing completion of initial drafts of their self-studies. The next stage involves two major activities: divisional visits and creation of review and study committees.

Divisional Visits: A series of "site visits" will be conducted over the next several

weeks to review the divisional draft documents. These visits will be conducted by teams headed by the chairmen of the self-study, DR. ROBERT REID, Vice President for Academic Affairs, and DR. MELVIN DENNER, Professor of Life Science. Purposes will include review of the written documents together with conversations on concerns such as accomplishments, needs, limitations, and future plans of the academic programs and divisions. These meetings will be informal in nature and last approximately two hours.

**MAJOR MEDICAL-DENTAL INSURANCE CLAIMS.** The following message has been received from Equitable concerning the filing of major medical-dental insurance claims: "We have received notice from our regional auditors that effective immediately, we will no longer be able to accept photocopies (xerox) of bills as proof of claims. Therefore, we are asking for your assistance in passing this information on to your employees. An exception to this ruling is that photocopies can be accepted when coordination of benefits is involved and we are the secondary carrier."

In accordance with the above communication, the Personnel Office will no longer accept photocopies (xerox) for claims purposes. **STAFF MEMBERS PLANNING RETIREMENT DURING 1979.** Any member of the faculty or staff planning to retire during calendar year 1979 should notify the Personnel Office immediately so that the necessary survivorship option forms may be filed with either the Indiana State Teachers Retirement Fund or the Indiana Public Retirement Fund.

If a retiring staff member files his intent to elect a co-survivor option at least one year in advance of his retirement date, the physical examination requirement at the time of retirement is waived.
