HISTORIC NEW HARMONY SOCIETY ESTABLISHED. A new Historic New Harmony Society has been established to help support the annual operation and preservation of the facilities at the site of the Harmonist and Owen communities which existed in the early 1800s. The annual budget runs \$500,000 and only 10 percent of that comes from admissions fees from visitors who come to see the re-creation of the color, events, and everyday life of the men and women who settled Indiana when it was the western edge of the frontier. Restoration and development have been supported in the past by the Lilly Foundation and the State of Indiana, and the new society will supplement those contributions to future activity.

The society is sponsored by the USI/New Harmony Foundation. Membership will provide free admission to all tour sites; a calendar of events in New Harmony; notification of special events sponsored by Historic New Harmony, Inc.; and invitations to events sponsored by the society. Membership categories include Student, \$10; Individual, \$20; Family, \$30; Sustaining, \$50; Donor, \$100; Benefactor, \$500; and Golden Raintree Patron, \$1,000 and up.

Interested persons are reminded that any gift made before December 31 will qualify for a matching gift from the Lilly Foundation, as well as provide a charitable contributions tax advantage that won't be available in 1987 for non-itemizers. USI DEVELOPMENT OFFICE OFFERS TAX ADVANTAGE REMINDER. This year, for the first time, a full federal income tax charitable deduction is available to all USI Foundation friends and supporters, whether or not they itemize their deductions. Every dollar given to USI before the end of the year will produce a meaningful tax savings... for every donor. However, this tax reward is available only for gifts made before the close of 1986; next year, only those who itemize tax returns will be able to use the charitable deduction. In addition, Indiana residents receive the benefits of the special Indiana tax credit. The State of Indiana allows a portion of contributions made directly to Indiana colleges and universities to be credited against state income tax. The allowable credit is 50 percent of your gift, limited to \$100 credit for an individual, \$200 for a joint return. If you are making a corporate contribution, you may claim a credit of 50 percent of the gift for your taxes, limited to \$1,000 credit or 10 percent of your corporation's adjusted gross income, whichever is less. GREAT FLOOD BOOK AVAILABLE. "The Great Flood of '37" is a 50th anniversary pictorial review of perhaps the greatest disaster that occurred in the Ohio Valley and is a result of the "Remember the Great Flood Day" held in September at the University Center. **Dr. Robert L. Reid**, vice president for Academic Affairs and USI professor of history, worked with **Mr. Larry Ordner**, director of media services, and the staff at The Evansville Courier in organizing the photographs and data collected that afternoon into the volume being published by The Courier. Dr. Reid said the book is a quality publication, printed by Keller-Crescent, and is ideal as a Christmas gift. (A coupon order form is available at the back of University Notes.)

The original program was sponsored by USI and the Vanderburgh County Historical Society and, in addition to the book, will result in a 50th anniversary exhibit that will open January 11 in the Town Hall Gallery at the Evansville Museum of Arts and Science. There will be an opening reception from 2 to 4 p.m.; the exhibit will continue at the Museum through January 25.

Other USI departments were involved with preparation of the exhibits. **Mr. Jay Friedrich**, chairman of the Division of Engineering Technology and professor of civil engineering, and USI engineering students developed a map that shows inundated areas of Evansville and the surrounding county at the crest of the flood, along with a flood hydrograph showing flood elevations from about the first of January through mid-February of 1937. The maps also were available at the September meeting at USI. Dr. Reid said video tapes shown then will be repeated at the January exhibit.

In a related effort, **Dr. Gordon C. Kelley**, chairman of the Division of Allied Health who emcees the Saturday "Radio Theater" on WSWI, the University radio station, has selected two programs that were broadcast during the time when Ohio flood waters were rising in the Evansville area and will replay them in connection with the anniversary observance. Dr. Kelley notes there were no national news broadcasts during that era so there is no mention of the flood. The programs selected are "Lux Radio Theater: Criminal Code," starring Edward G. Robinson, and the "Jack Pearl Show," a musical show with "jokes." The theatre program originally aired January 18, 1937; the Pearl show on January 10, 1937. Dr. Kelley will replay them on Saturday, January 17; the program starts at 11:30 a.m. In addition, **Mr. Joe Hulgus**, who emcees the 1-4 p.m. "Big Band Music" program on WSWI, will devote as much of his January 17 program as possible to music appropriate to the same time frame as the '37 flood.

HUMANITIES GRANT APPROVED. The Indiana Committee for the Humanities has approved a \$3,961 grant for USI to fund an exhibit of photos of Indiana, taken by a Farm Security Administration team of photographers from 1935 to 1943, and now on file in the Library of Congress in Washington, D.C. The exhibit and accompanying text -- "Back Home Again: Indiana as Seen Through the Farm Security Administration Photographs" -- is being prepared by **Dr. Robert L. Reid**, USI vice president for Academic Affairs and professor of history. It will be published next fall by Indiana University Press and the exhibit will be displayed in November-December, 1987, at the Indiana State Museum in Indianapolis, and in January-February, 1988, at the Evansville Museum of Arts and Science. After the local showing, the exhibit will be circulated throughout Indiana by the Indiana Committee for the Humanities.

Reservations are required for the candlelight walks and may be made by calling (812) 464-9595 or 682-4488, Monday through Friday. Tickets are \$4 for adults, \$2.50 for children.
