USI adopts administrative computer system **Bridges to lead implementation**

The University is about to embark on a three-year project revolutionizing administrative computer services on campus with Steve Bridges, controller and assistant director of the Business Office, at the helm.

In his temporary assignment as SCT Banner implementation project coordinator, Bridges will oversee USI's transition from SCT Plus to SCT Banner, a move that will affect SIS, the Student Information System; FRS, the Financial Record System; HRS, the Human Resources System; and ADS, the Alumni Development System.

USI adopted SCT Plus, a product of Systems and Computer Technology Corp., roughly 25 years ago. SCT Banner, also created by the corporation that designs software specifically tailored for higher education, embraces new technology that will facilitate improved services and increased data analysis, while decreasing the downtime previously required for maintenance.

"It's a completely different animal," Bridges explained. "It's going away from the mainframe technology to a client-server environment. It will be using computer servers instead of one massive machine, and it will be more functional and flexible for reporting. What we have now works well, but what we will have will work better."

SCT Banner will impact computer operations ranging from employee payroll to student registration as well as donor services, financial aid processing, grade reporting, admission, and Web applications.

"It's the software that runs everything, everything having to do with the administration of the University," said Dr. Robert Ruble, vice president for Business Affairs.

"This system has tremendous new capabilities, and it's Web-based, which means virtually anything that needs to be done can be done from any computer in the world that has Internet access. Because of that, it will have the look and feel of Windows, so it will be very intuitive as opposed to the current system that has mainframe screens."

To select the system, the University called upon the campus community to attend vendor presentations, share observations, and make recommendations.

"Everyone from the vice presidents down to the newest data entry clerk had an opportunity to come listen, ask questions, and offer suggestions. The comments were heard loud and clear, and that's why we went with the system we did," Ruble said.

"It's terribly important for the whole campus community to know this involves them. For the next three years, our lives are going to be a bit different. It's going to result in a few challenges and in a wonderful new system."

A timetable for the implementation and strategies for the transition are anticipated in November, and in about two weeks Bridges will be moving into the Wright Administration Building,

where his new office will be located in the former Human Resources Training Room. His telephone number, 812/465-7048, will remain the same.

"I look forward to this project and to the assistance that this project will need from the University community," Bridges said. "Information will follow as the direct plan becomes more clear."

Unanimously selected, Bridges was appointed to lead the project by the SCT Banner Executive Steering Committee comprised of the University's vice presidents.

He joined USI in 1989 as staff accountant and also has served as bursar, chief accountant, and controller. A USI graduate, he earned a bachelor's in accounting in 1988 and an M.B.A. in 1995.

When the project is complete, Bridges will resume his duties as controller and assistant director of the Business Office.

Biology seminar to explore evolution

Dr. Brian Metscher, assistant professor of evolutionary developmental biology, will present "Evolution: The Fish Still Say Yes!" as a seminar in the Department of Biology's fall series at 2:30 p.m. Friday, October 24, in Room 1101 of the Education Center.

According to Metscher, evolutionary changes are best understood as changes to the developmental processes producing the adult organism. Specific questions about how different forms develop can be derived from questions about evolutionary history and process, and these developmental questions can then drive laboratory investigations of evolutionary problems.

In the presentation, he will consider ongoing studies of the developmental evolutionary biology of fish appendages as a way of studying the evolution of vertebrate morphologies more generally.

Metscher joined the University in 2001. He holds a Ph.D. from University of California-Irvine.

The program is free and open to the public. Refreshments will be served before the presentation.

Mailing expert speaking at postal workshop

The River Cities Postal Customer Council Program and the United States Postal Service will present a fall workshop and luncheon on campus November 5 in the University Center.

Bob McClean, executive director of the Mailers Council, will be the featured speaker. "Is There a Future for the Postal Service?" will be the topic of his presentation.

Located in Arlington, Va., the Mailers Council is the nation's largest coalition of mailers and mailing associations. Members represent nonprofit and for-profit mailers using the U.S. Postal Service to deliver correspondence, publications, parcels, greeting cards, and payments. The council accounts for as much as 70 percent of the nation's mail volume.

A 26-year veteran of the communications industry, McClean has managed the council since 1996 and is an 18-year veteran of the postal community. A registered lobbyist, he represents the Mailers Council on Capitol Hill and has testified on its behalf before Congress and the President's Commission on the U.S. Postal Service.

His program will consider the future of the postal service and the latest news from Capitol Hill. The workshop also will include a variety of other presentations as well as vendor exhibits.

Event examining mind's healing power

A medical scientist, psychologist, and best-selling author will be the featured speaker at "The Power of the Mind to Heal: Psychoneuroimmunology to Energy Medicine" November 14.

The conference featuring Dr. Joan Borysenko will be held from 8 a.m. to 2:15 p.m. in Carter Hall.

Combining science, medicine, psychology, and spirituality, Borysenko's interests include behavioral medicine, stress and well-being, psychoneuroimmunology, women's health, creativity, and the great spiritual traditions of the world.

She holds a doctorate in medical sciences from Harvard Medical School, where she also completed post-doctoral fellowships in experimental pathology, behavioral medicine, and psychoneuroimmunology, and was an instructor until 1988.

A licensed psychologist, she is cofounder and former director of the Mind-Body clinical programs at two Harvard Medical School teaching hospitals. Her work with those programs is the foundation of her 1987 *New York Times* bestseller, *Minding the Body, Mending the Mind*.

Borysenko has appeared on *Oprah*, *Hour Magazine*, and *Good Morning American*, and her work has been featured in *U.S. News and World Report*, *the Wall Street Journal*, *USA Today*, *Reader's Digest*, *Success*, *Bottom Line*, *American Health*, *Glamour*, *Vogue*, *Ladies Home Journal*, *Living Fit*, and many other publications.

Mary MacGregor, M.S., an Evansville psychotherapist; Helen Emge Shymanski, B.A., C.Y.I., an area yoga instructor; and Mary Beth Davis, R.N., holistic specialist at Deaconess Hospital, will lead the concurrent sessions following Borysenko's presentation.

The USI School of Nursing and Health Professions and the Greater Evansville Affiliate of the Susan G. Komen Breast Cancer Foundation are sponsoring the conference.
