
PUBLIC HEARING SLATED. The USI Sociology Department is sponsoring a public hearing at 7 p.m. Thursday, July 5, in Forum III that will be one of three such hearings held around Indiana by the Indiana Department of Natural Resources. Under discussion will be the rules promulgated by DNR as a result of the Indiana General Assembly's 1989 "Burial Protection Act." Mr. Steve Lucas will be the DNR hearings officer in charge, assisted by Mr. Gary Ellis, representing the DNR Department of Historic Preservation.

Ms. Marjorie M. Jones, USI instructor in anthropology who was active in the clean up after area Native American grave sites were looted, said the new rules give the state jurisdiction over excavation, whether on public land or on private land with a landowner's permission. State permits must be obtained and failure to follow regulations has been made a felony violation of

FREEDOM FESTIVAL

MILEAGE RATE INCREASE. Effective July 1, the USI mileage reimbursement rate will increase to 25 cents per mile. The new schedule will be:

In-state travel: 25 cents per mile.

Out-of-state travel: 25 cents per mile - first 500 miles; 12 cents per mile - next 2,500 miles; 7 cents per mile - all miles over 3,000.
