## ISUE FOUNDATION MEMBERSHIP DRIVE UNDERWAY.

The Indiana State University Evansville Foundation is appreciative of the faculty and staff members who have, through an annual gift to the Foundation, supported various projects on campus.

Through this previous support, ISUE has been able to grow into a full service educational institution attentive to the needs of the people of this region and

it has become an integral part of public higher education in Indiana. Membership contributions to the Foundation are used wisely for University activities which are imperative to the development of our campus, and which are not provided for by State appropriations.

ISUE employees have always been supportive of the Foundation, especially through gifts to the Century Club and Varsity Club. The full value of your contribution is deductible on the Federal Income Tax return. ISUE may also benefit if the spouse of an employee who donates is employed by a company that provides matching gift contributions to nonprofit organizations.
