1. Minutes of Previous Meeting

The minutes of the January 27, 1989 meeting were approved as written.

2. Report from President Rice

4. General Education Advisory Committee-Ad Hoc Committee Report

The ad hoc committee considering a campus-wide General Education Committee presented a flow chart including an Advisory Committee parallel to the Coordinator of General Education.

A.Cardarelli made and M.Denner seconded a motion to amend the "Procedures for Modifying General Education Requirements" (approved by Faculty Senate on January 11, 1989) by rewording item 2 as follows:

The Coordinator of General Education has the responsibility for coordinating issues related to general education. The Coordinator must convene a committee consisting of an elected representative from each School which will serve in an advisory capacity to review all proposals regarding general education prior to their being submitted to the curricular committee.

The motion passed.

5. Humanities General Education Requirements

The Humanities General Education Requirements proposal, recently approved by the Curricular Committee, was presented by W.Everett and J.Gottcent. Others participating in the discussion were R.Mussard, D.Wolfe, and G.Pitman.

Following termination of discussion, Senate members were instructed to discuss this proposal with faculty in preparation for a vote at the next meeting.

6. Old Business

E.Marting presented the minutes of the joint meeting of the Faculty Hearing Committee and the Faculty Grievance Committee. This document contained a recommendation to combine the two committees into a single committee.

M.Denner made a motion, seconded by G.Eadie, to table this proposal until Senate members have had time for adequate consideration.

7. New Business

Nothing was presented for consideration as new business.
