# NHG hosts mixed media installation

The New Harmony Gallery of Contemporary Art presents "O Reader" by artist James A. Cogswell Jr. May 19- July 1, 2007.

"O Reader" is a mixed media installation that includes paintings, ceramic tiles, vinyl signs, and more. A reception for the artist will be held from 4 to 6 p.m. Saturday, May 19, and is free and open to the public.

Cogswell is a faculty member of the School of Art & Design at the University of Michigan, Ann Arbor. He holds a Master of Fine Arts degree in painting and drawing from the University of New Mexico and a Bachelor of Arts in English literature from Rhodes College.

Drawn to interdisciplinary projects, Cogswell has collaborated in performance works and installations with dancers, composers, scientists, and poets as well as other visual artists.

He has had solo exhibitions at Florida State University Museum of Art; the Urban Institute for Contemporary Art in Grand Rapids; the Walton Art Center, Purdue University; the Nashville Parthenon; the Krasl Art Center; the Amarillo Art Center; the Frances Wolfson Art Gallery of Miami; the Institute for Contemporary Art in Tallahassee; and the Jacksonville Art Museum.

He has lectured at colleges and universities around the country and has been invited to speak on his work at conferences in Japan, Ireland, Hungary, France, and Israel.

Cogswell's work can be found in the public collections of Yasuda Life Company of New York, Mbank of Houston, Barnett Banks of Florida, the Museum of Albuquerque, the City of Tallahassee, the Tamarind Institute, Valencia Community College of Orlando, Florida State University, and the University of Michigan.

# WebTips: Five Tips For a More Enjoyable Summer

Put down the sunscreen. Step away from those golf clubs. And turn off that Jimmy Buffett CD. Just because the semester's over and the students are gone doesn't mean your work is done. Your brain may be on a beach in Pensacola, but your body is still here, in Evansville, staring at a screensaver of a beach in Pensacola. So what better time to take a long, hard look at your Web site, update content and organize your Web folders? Spoken like a true computer geek, right? Well, bear with me for a second. I'll give you five good reasons why you should take care of this now:

1. Most of the information posted on the USI Web site is time sensitive. If managed properly, it is chocked full of dates, names, and numbers to help students get through the spring semester. Most of that information is now old, useless, and potentially misleading.

2. Web folders have a tendency to get untidy very quickly when we're busy. Because updating sites on our server can be done in real time, it is very tempting to make a quick change – add a PDF or an image – and just dump elements anywhere in the folder. Take a moment to put images and graphics in the "images" folder, pdfs in a "pdf" folder, and delete old photos and documents. Organizing these things now means not tearing your hair out looking for them 3. We've just finished another illustrious year at USI and with that we've told many compelling stories, chronicled dozens of campus events, and snapped hundreds of new photos – some of which might fit nicely on your web pages.
