USI PRESIDENTIAL SEARCH COMMITTEE NARROWS CHOICE TO FOUR FINALISTS

Mr. Bruce H. Baker, chairman of the USI Board of Trustees, announced the names of the four finalists in the USI presidential search at a press conference November 15 in New Harmony. The finalists include:

- Dr. Mark Auburn, executive vice president, University of Akron
- Dr. Nancy Belck, provost and vice chancellor for Academic Affairs, Louisiana State University-Shreveport
- Dr. H. Ray Hoops, vice chancellor for Academic Affairs, University of Mississippi
- Dr. G. Warren Smith II, president, Southeastern Louisiana University

Dr. Auburn, 48, an Ohio native, has been with the University of Akron in Akron since 1991, first as senior vice president and provost and more recently as executive vice president. The University of Akron is a comprehensive, urban, doctoral-granting institution of 28,000 students.

Dr. Auburn was vice chancellor for Academic Affairs at Indiana University-Purdue University, Fort Wayne, from 1988 to 1991, and vice president for planning in the University of Arkansas system from 1985 to 1988. He received a Ph.D. in English with honors from the University of Chicago in 1971. He is widely published and the author of two books.

Dr. Auburn is married and the father of two adult sons. His wife Sandra is executive director of a community foundation in Akron.

Dr. Belck, 50, has been provost and vice chancellor for Academic Affairs at LSU-Shreveport since 1991. Established in 1965, LSU-Shreveport is a comprehensive public higher education institution with 4,364 students and offers academic programs through the master's level.

Dr. Belck was dean and professor in the College of Education, Health, and Human Services at Central Michigan University from 1987 to 1991. She served as interim

provost and vice president for Academic Affairs at Central Michigan from July 1988 through June 1989. She received a Ph.D. in family ecology/communications from Michigan State University in 1972. She is widely published and has a record of community service in Shreveport.

Dr. Belck is married to Jack Belck, a communications/marketing consultant. They have a son in graduate school.

USI BOARD APPROVES MASTER'S PROGRAM; ACCEPTS HOUSING

The USI Board of Trustees, meeting Monday in New Harmony, approved a master's degree program in nursing which would offer three major areas of study: family nurse practitioner, acute care nurse practitioner, and case manager/nurse administrator.

Dr. Nadine Coudret, dean of the School of Nursing and Health Professions, said, "The current state of the health care system in the United States has prompted a national health care reform effort centered on increased access to high quality, cost-effective health care. Advanced-practice nurses are prepared for a comprehensive role in health care reform and are cost-effective providers.

"The master's degree program at USI can help meet the health-care needs in medi

cally underserved areas of rural Indiana while keeping costs down. Assisted with modern technology, nurse practitioners have an expanded role in patient care, working in collaboration with physicians."

Advanced-practice nurses work in child-health, prenatal, and family planning clinics, hospitals, and doctors' offices, among other sites.

The USI master's program may be the first in Indiana for family nurse practitioners; another is under consideration at Indiana State University, Terre Haute. The USI proposal will be submitted to the state Commission for Higher Education for consideration. Grant applications for funding the program also are being submitted to the Department of Health and Human Services.

In other business, the Board agreed to seek architectural proposals in the construction of an estimated \$4.1 million addition to the University Center to provide much needed space for student activities. The center was built in 1974 to accommodate 5,000 students, while enrollment this year reached 7,551 students. Space is needed for conference rooms, lounge, auditorium and ballroom, offices, and meeting rooms for student organizations.

The Trustees also agreed to accept a gift of 31 apartment buildings located adjacent to the campus from Southern Indiana Higher Education, Inc. (SIHE, Inc.), a nonprofit corporation which supports the needs of higher education in southwestern Indiana. The units, known as Mid-America Student Housing (MASH) and Campus Apartments, can accommodate 1,400 students and have a current replacement value of \$14 million. Further approvals will be sought from the Commission for Higher Education, the State Budget Committee, and the governor.

rector of the USI Center for Communal Studies and professor of history, participated in the 18th annual conference of the Society for Utopian Studies held November 5-7 in St. Louis. Dr. Barber presented the paper "Xenophobia Toward Refugees: Foreshortened Utopia" for a panel on "Utopianism in Asia and the Third World." Dr. Pitzer chaired a panel on "Intentional Communities in the South."

Dr. Jong C. Rhim, assistant professor of finance, and Dr. Mohammed F. Khayum, assistant professor of economics, presented a paper entitled "Composite Forecasts of Foreign Exchange Rates" at the 1993 Conference of the Association for Global Business held November 4-6 in Chicago. Dr. Hoops, 53, has been vice chancellor for Academic Affairs at the University of Mississippi since 1988. Ole Miss is a state university with Schools of Medicine, Law, Engineering, and Pharmacy and offers a broad range of doctoral programs. Enrollment is 11,000 students.

Dr. Hoops was chair of Committee '95, a statewide group charged with setting the course for Mississippi education at all levels for the 1990s. The committee's work received national acclaim and the State Council of Governments' Innovations Award.

Dr. Hoops was associate vice chancellor for Academic Affairs for the Oregon State System of Higher Education from 1985 through 1988. He also served as president at South Dakota State University from 1984 through 1985 and was vice president for Academic Affairs at North Dakota State University from 1980 to 1984. His Ph.D. in audiology and speech science is from Purdue University. He is a native of Illinois.

Dr. Hoops and his wife Rosalinda a hotel and restaurant management consultant, have a daughter who is in college.

Dr. Smith, 52, has been president at Southeastern Louisiana since 1986. Southeastern is the state's fastest-growing university with an enrollment of 11,400 students. Located in Hammond, Southeast-

ern is a public institution offering academic programs through the master's level.

Dr. Smith was dean of the School of Sciences and Technologies and professor of sciences at the University of Houston-Clear Lake from 1979 through 1984. For ten years prior, he was professor of chemistry and head of the Department of Chemistry and Chemical Engineering at the University of Alaska. He is regarded as a scholar in the field of chemistry and higher education. He holds a Ph.D. from Cornell University and is a native of Missouri.

Dr. Smith's wife Constance is director of institutional research at Southeastern University.

In his announcement, Mr. Baker expressed the Board of Trustees' appreciation to the Presidential Search and Screen Committee for its "diligence and careful screening of the candidates," saying the 23-member committee of faculty, staff, students, alumni, and community representatives has given the University "an excellent field of finalists."

The committee recommended five finalists from more than 100 applicants. The fifth has withdrawn to take another position. The next step in the search process will be visits to the University by the finalists, probably early in 1994.
