3. Adaptation to ISUE of Position Papers Issued by President Landini Entitled "Criteria for Evaluation of Faculty Performance" and "Duties and Responsibilities of Chairpersons"

Discussion of paper on "Duties and Responsibilities of Chairpersons"--Professor Follis indicated probable objections from the Humanities Division to the changes, indicating the Chairperson serves at the pleasure of the Vice President for Academic Affairs. There were minor typographical corrections, and other questions of concern. This item will be on the next agenda.

Discussion of paper on "Criteria for Evaluation of Faculty Performance"--Professor Follis indicated concern with the idea of merit increases being built into the salary base and expressed a desire to have the concerned faculty members appear at the next meeting for further discussion. This item will be scheduled for the next meeting. The faculty members are welcome to submit statements.

Chairman Venatta also asked Council members to study the statement on personnel files for the next meeting.

4. President's Remarks

President Rice was not in attendance.

Dr. Reid paid tribute to the work of the Physical Plant personnel in keeping the campus open and requested tolerance and understanding in adapting to the unusual weather conditions.
