12th annual psychology conference slated at USI

Three speakers will be featured for the 12th annual Mid-America Conference for Teachers of Psychology (MACTOP), slated Friday and Saturday, October 13-14, in the University Conference Center.

The USI Psi Chi Chapter will sponsor two pre-conference presentations by Dr. Steve Davis of Emporia State University, Kansas. He will speak on "Student Involvement" and "Cheating" at 10 a.m. and 12 noon Thursday, October 12, in UC350; the latter session is open to the public. Dr. Davis is a past president of the national Psi Chi psychology honorary and is a recognized expert on student cheating, based on studies that have drawn responses from students and faculty nationwide. He and Dr. Joseph Palladino, USI psychology professor and MACTOP founder, are co-authors of the recently published textbook *Psychology*, which has met with much success.

Other MACTOP speakers will be Dr. Mitch Handelsman of the University of Colorado at Denver, who will discuss "The ethics of teaching: Beyond virtue" at the

opening general session at 10:45 a.m. Friday and Dr. Douglas Bernstein of the University of Illinois, who will present the after-dinner talk Friday evening on the topic "Stranger than truth: Student excuses and what to do about them." Dr. Handelsman was CASE Professor of the Year in Colorado and also received this year's Teaching Excellence Award from the American Psychological Association Division on Teaching.

UC groundbreaking October 9

Groundbreaking will be held at 4 p.m. Monday, October 9, for the \$4.7-million expansion/renovation project at the University Center. Students, faculty, staff, and friends will participate. The University Center will not be closed during the work, which is expected to take about 12 months.

The USI Board of Trustees Finance Committee, acting for the full Board, accepted the bids of six contractors September 22. Deig Brothers Lumber and Construction Company was named general contractor. Other contracts went to Premier Electric Company, Arc Mechanical Co., U.S. Industries (roofing), Johnson Controls, and Flotech (test and balance).

in 1974. There will be an additional entrance on the south side, a ballroom on the second level, and a multipurpose area with the capacity to seat 530 people for dining and 750 for meetings. There also will be a computer lab, a small art gallery, a formal meeting and dining area, and more space for Student Life staff offices, conference facilities, student publications and other student activity offices, and for student recreation and lounge areas.

Quaker Oats turnaround to be explored

Representatives of Quaker Oats Company at Danville, Illinois, will be featured on Tuesday, October 10, in the next "Partners for Success" presentation of the Southern Indiana Labor-Management Education Forum.

The program at 9 a.m. in the Conference Center will be presented by Mr. Jim Pigg, recording secretary of Local 347, American Federation of Grain Millers (AFGM), and Ms. Kristen Doster, Human Resources supervisor. The entire Local 347 Executive Committee is expected to participate in the program.

The Danville plant was operating under a traditional mindset in the late '80s: the 408 employees who made Chewy Granola Bars, Oat Squares, Captain Crunch, and other Quaker cereal products were expected to tend to their business and let management manage. Poor labor-management relations led to a strike in 1988. During 1991 negotiations, the two sides discovered they shared the same values and began to develop a vision. Their efforts to

seek commitment, trust, and honesty, balancing employee and company needs, led to contract settlement six weeks early, the first plant to settle early in company history.

Employees not only helped increase production by two million cases but created two new flavors for the chewy bars. The plant now has operational flexibility, improved wages and benefits, and a profitable operation in the face of intense competition from such giants as Kellogg, Ralston, and General Mills.

Mr. Pigg and Ms. Doster experienced plant transition first-hand and will discuss changing the old mindset, determining shared values, the challenges ahead, and what can be learned from the Quaker experience. Area plants are urged to have labor and management attend the 2 1/2-hour session as a group. Early registration is recommended due to limited seating; the fee is \$10 per person. The session also will feature a pre-recorded interview with Mr. Alfredo J. Estrada, publisher of Hispanic magazine, and attempt to explore several issues that sponsors feel are being overlooked — the impact on college admissions for students of color and women, job and career prospects, role of white women, campus polarization, and minority faculty recruiting and hiring practices, among others. He began teaching in Brooklyn in 1965 and has since held faculty positions in Miami, Virginia, Illinois, Georgia, Michigan, and Ohio, interspersed with theatrical work — primarily directing — in California, Virginia, Pennsylvania, Cincinnati, and New York City. He currently serves on the board of Colleagues Theatre Company in New York City.
