1. Election of council secretary

Professor Everett proposed the office rotate among the Council members excluding the chairman. The motion failed.

Professor Willett was elected secretary.

2. Approval of minutes from Session #1

The minutes of the September 2, 1983 meeting were approved as amended.

4. Reports

President Rice distributed a post card with an aerial view of the campus which will be for sale in the Bookstore.

The groundbreaking for the campus housing will be in the afternoon of October 17, 1983.

Enrollment is up by 142 students over last year.

The Commission on Higher Education has requested a plan for separation be submitted. The Board of Trustees is expected to view the proposed plan as a function of the legislature but to not be opposed to separation.

President Rice suggested reviewing the Senate Resolution Number 8 report which was on separation.

The issue is expected to be addressed by the Indiana Legislature in January or February, 1984.

A general discussion on the possible effects separation would have on ISUE and its faculty followed.

5. Charges to standing committees

Professor Goss announced that he had charged the Curricular Committee to modify its proposal for curricular changes deadlines.

He also announced that he had referred the question of faculty liability on dossier recommendations to the Faculty and Academic Affairs Committee.

Professor Goss reported that he had received one copy of the report from the Non-Traditional Students and Program Committee. He will refer it to the Student Academic Affairs Committee for consideration of the services of the institution to non-traditional students.

6. Old Business

Professor Dunn announced that the General Education Committee is still functioning and will be considering the responses to its questionnaire this year.

Professor Petranek introduced a discussion on the goals of the campus report. President Rice responded that the Academic Planning Council is discussing these goals. Vice President Reid stated that this report is a broad document and the purpose of its discussion at the Fall Faculty Meeting was to assure that nothing had been missed and that something totally inappropriate would not be included.

7. The meeting was adjourned at 8:09 A.M.
