The University of Southern Indiana Foundation has inaugurated a new program in which students who apply at USI and are valedictorian or salutatorian in high schools commissioned by the Indiana Department of Public Instruction will be offered annual scholarships valued at \$4,400.

The awards are renewable for four years if the recipients remain full-time students with at least a 3.2 cumulative grade point average their freshman and sophomore years and a 3.4 GPA thereafter.
