Dr. Marr, the first USI men's tennis coach from 1972 to 1995, replaces Dr. Charles Bertram, who died in June. The FAR is a member of an institution's faculty or administrative staff designated by the institution's chief executive officer to represent the university and its faculty in the NCAA and the GLVC. Dr. Marr also will be chair of the Athletic Advisory Council at USI.

Head softball coach **Ms. Beth Watson** has accepted the duty of senior women's administrator (SWA) in the Athletic Department. Ms. Watson assumes duties held by Ms. Chancellor Dugan.
