

# USI Board of Trustees approves 1995 schedule of fees, master's degree in accountancy, current budget

The USI Board of Trustees approved a fee increase for students at the July 7 meeting in Terre Haute, Indiana, which was hosted by Mr. Charles Combs, president and CEO of Merchants National Bank, Terre Haute, and a vice chairman of the Board.

The Trustees approved increases of \$3.50 per credit hour for Indiana resident undergraduate students and \$5.25 per credit hour for Indiana resident graduate students. Mr. Richard Schmidt, vice president for Business Affairs, explained that "for the majority of USI students who are full-time Indiana resident undergraduate students taking a 15-credit-hour load, the new fee will mean about a \$100 increase for the year."

The approved increases allow USI to continue providing the lowest fees among Indiana's state-assisted, four-year degreegranting universities. USI fees will be \$75.75 per credit hour for a resident undergraduate student and \$111.25 per credit hour for a resident graduate student. The Board also approved an \$8.75 increase for non-resident undergraduate students, making their per-credit-hour fee \$184.75, and a \$10.50 increase for non-resident graduate students, which puts their fee at \$222.50 per credit hour. A new degree program, the Master of Science in Accountancy, was approved by the Board. It will provide graduate-level instruction and training for beginning professional accountants and for those in the profession who want to gain more knowledge in their field to qualify for advancement. Dr. Philip Fisher, dean of the School of Business, explained that effective January 1, 2000, anyone wishing to sit for the certified public accountant (CPA) exam in Indiana, Illinois, and Kentucky must have completed a minimum of 150 semester hours. A person with an undergraduate degree would a minimum of 124 semester hours. Coupling the new 30-hour accountancy graduate degree with an undergraduate program would allow eligibility for the CPA exam.

Dr. Fisher said there is no other master's program in accounting in the Tri-State to fill this need. He noted, "This program would be particularly suitable for someone with an undergraduate degree in accounting. It also would be relevant for those with an undergraduate degree in some discipline other than accounting who wish to become CPAs. Practicing CPAs and management accountants who wish to remain current in their field and meet the challenges of an increasingly complex and growing profession would, likewise, find it beneficial."

The program will be submitted to the Indiana Commission for Higher Education for approval. With favorable action, it would be implemented in Fall 1997.

Mr. Schmidt presented the 1995-96 budget for Board consideration. He said the revenue sources which support increases over the previous fiscal-year budget include an increase in State appropriation – an adjustment for prior enrollment increases and for debt service – and an increase in the student fee rate. The Board approved the \$32.59-million budget.

The Board also approved plans for the University Center addition, presented by architects from Veazey Parrott and Shoulders of Evansville. The expansion will nearly *continued on page 2*

The USI Athletic Department and South Central Communications Corporation have signed a three-year agreement for Screaming Eagles basketball to be aired on WAZ-TV Channel 52 and WJPS/AM1400.

WAZ-TV will televise both the men's games -- 15 at home and seven away -- and three of the women's home games in 1995-96. All games will be tape-delayed and aired at 10:30 the same night. USI retains the right to have four road games aired live in Evansville.

WJPS will air all of the men's 1995-96 basketball games and will add an AM/ SSB broadcasting system (known as power-side) to increase the coverage of its AM signal.

The play-by-play for both television and radio will be provided by Mr. Darrin Smith, who has been the voice of the Eagles since 1991 on WAZ-TV.
