Case management conference at USI in May

The 2000 Case Management Conference will be held from 8 a.m. to 4:30 p.m. on Thursday, May 11, in Carter Hall, University Center. This conference is for case managers, discharge planners, nurses, physicians, social workers, students, and other health care professionals.

Dr. Toni Cesta, director of Case Management for St. Vincent's Hospital and Medical Center in New York City, will deliver the keynote address, "The Future of Case Management" at 8:15 a.m.

The conference will cover issues in case management including innovative strategies for the future, key elements of the case management process and its implementation in a health care setting, and the federal and state laws and regulations in the role of case management.

Featured sessions include "Pain Management," "Economics in Cardiology Care," "Meeting the Challenges of the Elderly in the Community," and "Yoga as a Healing Modality."

Visiting artist lecture slated for April 13

Mr. Bruce Robbins, president of Lill Street Studios, Gallery and Learning Center in Chicago, will present a contemporary ceramics in Chicago slide lecture at 7 p.m. on Thursday, April 13, in Kleymeyer Hall, Liberal Arts Center at University of Southern Indiana. He is the final featured artist in the Spring Visiting Artist Series. Robbins' lecture is sponsored by the USI Department of Art and Music. The lecture is free and open to the public.

For more than 20 years, Mr. Robbins has been instrumental in developing and presenting art education programs in Chicago and the Midwest. Some of his projects include the Lill Street Studio, a cooperative studio space; affiliation with DePauw University to provide art majors ceramics instruction; Gallery 37, a program that provides hands-on art experiences for inner-city children; and a summer arts program for the Cultural Affairs Office of the Mayor of Chicago.

Mr. Robbins also will serve as juror of the USI Student Art Exhibition which opens with a reception from 2 p.m. to 4 p.m. on Sunday, April 16, in the University Conference Center. The show will continue daily from 10 a.m. to 6 p.m. through April 22. It is open to the public.

Dr. Helen Sands, professor of communications; Dr. Larry Arp, chair of Information Systems and Business Education Department and associate professor of business education; and Dr. James Blevins, dean of the School of Liberal Arts and professor of English; will be honored for their years of service to the University of Southern Indiana at 3:15 p.m. on Wednesday, April 19, in Carter Hall, University Center. They will retire this year.

Mr. Phil Young, general manager of the Fabricated Products Division of Bridon American Corporation, will discuss how his company competes in the world market place at the next luncheon meeting of the Tri-State World Trade Council from 11:30 a.m. to 1 p.m. on Thursday, April 20, in Carter Hall, University Center.

Located in Oakland City, Indiana, this division of Bridon International, which has ISO 9000 certified manufacturing facilities in the United States, United Kingdom, New Zealand, and Malaysia, is the largest wire rope manufacturing company in the world. The company produces wire rope, boom supports, and assemblers that are used on giant draglines, shovels, cranes, and oil drilling rigs. In addition, Bridon manufactures structural assemblies used for suspended roofs, cable-stayed bridges, and tower guys.

Young will describe how this small firm successfully markets, sells, and services its products throughout the world; going head-to-head against strong competitors. His remarks will include:

- * What it takes to be successful in an export business.
- * The location factor - how important is location in international trade?
- * Some lessons his firm has learned and is continuing to learn while engaging in international commerce.
- * Comments about manufacturing and competing in the global marketplace that might be useful to any firm considering exporting.

The Tri-State World Council, which meets on the third Thursday of each month, invites area businesses to share their experience in international markets. The Council provides networking opportunities, trade-related information, and educational events to raise awareness of the importance of trade and serve as a resource for tri-state firms entering the global marketplace.

Dr. Larry Arp came to USI as associate professor of business in 1972 and has taught business communications, computer programming, and personal finance. In 1991, he was named chair of the Information Systems and Business Education Department. Dr. Arp helped establish the Computer Information Systems program at USI and was among organizers of the University's Distance Education Program.

He has been active with various University committees, including serving as chair of the Faculty Council (now Faculty Senate) from 1977 to 1978. In 1987, Dr. Arp was named USI athletic director and after his four-year tenure he returned to full-time teaching.


"Perhaps Dr. Arp's most important contribution lies in the many outstanding men and women who are business educators in secondary schools throughout the region," said Dr. Phillip Fisher, dean of the School of Business. "As a department leader, Dr. Arp has been an innovator. For me, his most significant innovation has been his experimentation with and eventual adoption of programmed learning to deliver our freshman course in basic computer skills. This has resulted in a course that is popular with students, develops the skills they need, and is inexpensive to deliver to more than 1,200 students each year." Dr. Fisher continued, "A second area of innovation has been in program development. Under Dr. Arp's leadership, his department and area representatives from industry completely revised our computer information systems (CIS) major, developed a post-baccalaureate program in computer information systems, and developed a proposed major in applied computer science. The CIS major is our fastest growing major, increasing from fewer than 20 to more than 220 over the past five years. The post-baccalaureate program began in fall 1999 and enrollment has exceeded our projections. These developments, along with the proposed major to be offered in 2001, will greatly strengthen our University's ability to serve the employment needs of our region and to offer our students high paying jobs with opportunities for growth."

His participation in professional organizations includes serving as president of the Indiana Business Educators Club and past-president of the Indiana Business Education Association. In 1986, the state school superintendent appointed him to the Indiana Advisory Council for Business Education. Dr. Arp was Indiana's representative to the North Central Business Education Association from 1994 to 1996.

Articles by Dr. Arp have been published in the *Office Systems Research Journal*, *The Delta Pi Epsilon Journal*, and *International Business Schools Computing Quarterly*.

Dr. Arp received his B.A. from University of Northern Iowa, M.A. from Adams State College, Colorado, and Ed.D. from Utah State University, Logan.

"I want to thank the many outstanding faculty and staff that I have worked with and been associated with over the past 27 years at USI," said Dr. Arp. "Many changes have occurred since we grew from ISUE to USI. The University has provided a very stimulating environment for me, abounding with opportunities for growth professionally and personally. I will miss being a part of helping to forge the future for the campus." He plans to travel with his wife and play golf.



Dr. James Blevins came to USI in 1966 as assistant professor of English and has taught literature, film, and composition. He was chair of the University's Division of Humanities from 1969 until 1988 when the divisions were organized into schools and he was appointed dean of the School of Liberal Arts. His major contributions to the development of the School of Liberal Arts include opening of the \$15.2 million Liberal Arts Center, growth of faculty and academic programs in the school, and expansion of the summer seasons at The New Harmony Theatre and Lincoln Amphitheatre, two regional professional theatres.

"Through their combined vision, Dr. David Rice, president emeritus, and Dr. Blevins brought about the success of Lincoln Amphitheatre and The New Harmony Theatre," said **Mr. Steven Renner**, managing director of Lincoln Amphitheatre and manager of Southern Indiana Theatres. "They created great public relations for USI by drawing people from outside southwestern Indiana to the summer theatres."

In the 1980s he directed the University production of the Arthur Miller drama, *All My Sons*, and last fall the play was staged under his direction to open the Helen Mallette Studio Theatre, located in the Liberal Arts Center.

He has been a member of the Indiana Committee for the Humanities, the Education Advisory Panel of the Indiana Arts Commission, and project director of several Indiana Committee for the Humanities grants to extend understanding of cinema to the southwestern Indiana community.

"Like David Rice, Jim Blevins laid the groundwork for things at USI that will be around as long as the University itself exists," said Dr. Thomas Wilhelmus, assistant dean of the School of Liberal Arts. "Not only was he one of 'the Founders' of USI - someone who helped determine the culture of its largest academic unit during a period of unparalleled growth and development - he did this work with intelligence, judgment, good taste, and a remarkable eye to the future. Chair of the old Humanities Division, dean of the School of Liberal Arts, producer for all three of the University's theatres, supporter for any number of arts and humanities initiatives both on and off campus, recipient of the Mayor's Art Award and of recognition at state and national levels, he is what one journalist some years ago called him, a visionary worthy of our gratitude and respect."

Dr. Blevins has assisted with the University's mission to promote the cultural development of the region and was instrumental in the organization of the USI Society for Arts and Humanities to broaden the influence of the University and the community upon each other in the development of humanities programs. He was recognized for his efforts in 1995 by being named the recipient of the Mayor's Art Award, the city's most prestigious award for contributions to Evansville's arts community.

After 34 years at USI, Dr. Blevins said, "I am fortunate to have spent a large part of my adult life helping to bring to birth and to nurture a vital young organization which has been so important to so many and which has a glorious future ahead of it. All of my life I have loved to read, and I have enjoyed the friendships of young people. I don't even feel guilty that I have found meaningful work as well as a job in what for most people are hobbies."

Dr. Blevins received his B.A. from David Lipscomb College, and an M.A. and Ph.D. from George Peabody College. He completed two terms of post-doctoral study at the University of California-Los Angeles.



Dr. Helen Sands came to USI in 1969 to teach communications. She was chair of the Communications Department 1970 - 1973 and 1976 - 1979. She has been active in numerous student-oriented activities as sponsor of the Communication Arts Club, co-host of the annual high school invitational speech meet, and sponsor of the Indiana Iota Chapter of the Alpha Chi National Honor Society.

"Dr. Sands fosters a sense of community for students in the Communications Arts Club allowing us to forge working relationships as well as friendships," said Mr. Ryan Helzerman, a communications major, student representative on the Board of Trustees, and president of the Communication Arts Club. "In the classroom, she draws out the best in her students and kindles a deep appreciation of the communication arts and for living. Dr. Sands looks at a situation from many angles and teaches students to treasure diversity and champion education. I am a better thinker, learner, and communicator thanks to her wisdom and friendship." Mr. Helzerman continued, "The department is an extension of Dr. Sands' vigor and personality. We learn more than how to give speeches; we learn how to be better human beings."

Active in University committees, she served on the Faculty Council for two two-year terms and served as chair from 1981 to 1982. Dr. Sands served as chair of the Humanities Division Promotions Committee from 1974 to 1980 and currently serves as Communications Promotions Committee chair.

"She has been the pillar of this department for 31 years," said **Dr. Dal Herring**, chair of the Communications Department. "No one in this department is more loved by students and faculty than Helen for her helpful, caring, and concerned manner. When communications alumni come back to visit, they seek her first. Neither the department nor the school will be the same without her."

Dr. Sands is a member of several professional associations and has served as chair of the Indiana Speech Association. In the 1970s she served on the Advisory Board of the Indiana Governor's Commission on the Status of Women.

"Helen is truly respected by her colleagues and has been a role model for hundreds of USI students with whom she generously shared her wisdom, advice, and life experience," said **Ms. Mary Schroeder**, assistant professor of communications. "She will be remembered as an outstanding teacher who guided students not only in their completion of projects, but also in their pursuit of career goals. In addition to positively affecting the lives of the students and faculty, she has also greatly influenced my life with regard to offering her suggestions, encouragement, and direction. I treasure our friendship of 31 years and I will truly miss her."

Published books by Dr. Sands include *Public Conversations: Building Skills and Confidence* and *Oral Interpretation: The Art of Performance*.

She received her B.S. in speech education from University of Vermont and her M.S. and Ph.D. in communications from Southern Illinois University.

"My greatest challenge from the beginning to the present day has been to bring out the best in my students - to inspire them to do their best work and to become the best people they can be in life," Dr. Sands said. "While the campus has enjoyed tremendous growth over the years, the Department of Communications has burgeoned at an even greater pace. I've been blessed with wonderful students, great friends and colleagues, and a family that has supported me every step of the way. I've had 31 years doing what I love most. Teaching is, without a doubt, a rewarding profession."

One-man show on black leadership

Mr. Phillip Walker, African American Drama Company (AADC) artistic director, will perform *Can I Speak for You Brother?*, a one-man show on black leadership which he wrote, at 7 p.m. on Wednesday, April 12, in Carter Hall. His appearance is sponsored by the USI Activities Programming Board and is free and open to the public.

Mr. Walker will depict nine black men who fought for a dignified place in American society. Martin Luther King Jr., Malcolm X, Frederick Douglass, Booker T. Washington, and W.E.B. DuBois are some of the personalities Walker will portray.

A Chicago native, Mr. Walker became involved with the AADC, in part, because black history was not taught in the school system that he attended as a child.

In addition to *Can I Speak for You Brother?*, Mr. Walker wrote AADC's one act plays *Sister*, *Can I Speak for You* and *Get Down*. His articles have been published in *Interview*, *Encore*, and *City Arts Monthly*.

Mr. Walker received a B.A. from Loyola University, an M.A. from University of Illinois - Urbana, and an M.F.A from the University of California-Davis. He taught theatre at Lincoln University, the University of Illinois, San Francisco's Exploratorium, and Wayne State University. Walker also has chaired the Dramatics and Speech Department at Fisk University.

Walker's acting experiences include Francis Ford Coppola's *Peggy Sue Got Married*, *Howard the Duck*, and *Save the Last Dance for Me*.

His directing credits include AADC's *Ain't I A Woman?*, *Norman is That You?*, and *Sister, Can I Speak for You?*
