a. The budget bill has been delayed in the Indiana Legislature. The amended bill from the joint committee was favorable to USI. There was an adjustment to the base funding. The budget will be reopened when the Legislature meets in the extra session.

4. **Report from Vice President Reid**

a. Robert Diamond of Syracuse University will be on campus on September 17 & 18, 1997, to present two workshops for faculty, one on promotion and tenure issues, and the other on curriculum design and assessment.
b. During the summer the parking lots will be repaired and the Boulevard and Clarke Lane resurfaced.

7. **Standing Committee Reports**

c. The Economic Benefits Committee reported on methods of compensation for summer teaching. Following a discussion of the report, L. Goss moved to accept the report. S. Wolfe seconded the motion and the motion carried.

10. **Announcements**

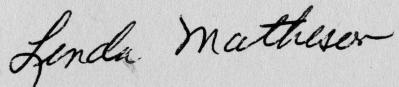
a. Senators were urged to attend the USI Theater production on Thursday, Friday, or Saturday.
