1. Approval of Previous Minutes

Minutes of March 28, 1979 were approved as amended.

2. President's Remarks

Dr. Reid stated that the University will pick up the retirement contribution of .5%.

3. Annual Report of the Curricular Committee

The Annual Report of the Curricular Committee was approved as amended. Under Education - Modified Courses, the number should be 47 instead of 46. This was changed by the Curricular Committee. Mr. Cook moved that the report be approved as amended. Dr. Petranek seconded the motion.

4. Annual Report of the Faculty Council

The Annual Report of the Faculty Council was presented to the Council. Dr. Petranek moved that the report be accepted, Dr. Mussard seconded the motion. Motion carried.

5. Report from Economic Benefits Committee

The Economic Benefits Committee stated that they do not have sufficient time to respond to our request on salary increases in regard to the EBC Report, Table #5.
