1. The meeting was called to order at 3:00 p.m. by Dr. Kinsey.
2. The minutes of Session 10, April 5, 1991, were approved as amended.
3. Report of the Vice President for Academic Affairs.

Dr. Reid reported that preregistration seemed to go well. There are 300 more preregistered this year than last.

Dr. Barnett is coordinator of the Presidential Scholars program. She has asked for assistance from each School and plans on having faculty and student mentors.

4. Report of the Assistant Vice President for Business Affairs.

Richard Schmidt reported for the University Center Coordinating Council. The Council is chaired by Barry Schonberger, and other committee members are Marjorie Labhart, Linda Cleek, Betty Walden, and Dr. Jones. As part of their efforts to plan an addition to the University Center, the committee has visited several campuses to examine their student centers. Dick Schmidt requested faculty to bring their suggestions to committee members.

5. Annual Reports of Standing Committees.

a. Motion made (Denner) and seconded (Hooper) to accept the report of the Grievance Committee. Motion passed.

b. Motion made (Denner) and seconded (Hooper) to accept the report of the Curriculum Committee. Motion passed.

It was noted that one technical change proposed in the report is that changing the first digit of a course number shall not

be regarded as a minor change. Motion made (Denner) and seconded (Kocakulah) to implement the recommended changes in the report. Motion passed.

c. Motion made (Hooper) and seconded (Hildebrand) to accept the report of the Student Academic Affairs Committee. Motion passed.

d. Motion made (Denner) and seconded (Kocakulah) to accept the report of the Faculty and Academic Affairs Committee. Motion passed.

Motion made (Denner) and seconded (Shaw) to amend Item f under Charge #1 of the Faculty and Academic Affairs Committee report to read, "Faculty teaching independent-study, independent-research, or by-arrangement courses at the 400 level should receive one hour of assigned time for every ten student credit hours generated in such courses with the approval of the department chair and/or dean. Motion passed.

Motion made (Koob) and seconded (Kocakulah) to amend Item i under Charge #1 to read, "Full time, qualified, tenure-track faculty should receive preference for teaching intersession and summer courses in a fair and equitable manner as determined by the department chair or dean. Motion passed.

Motion made (Denner) and seconded (Hildebrand) to forward the report of the Faculty and Academic Affairs Committee as amended. Motion passed.

Curt Serbus reported that the Faculty and Academic Affairs Committee received five proposals for Faculty and Creative Research awards. The committee voted to recommend funding of all proposals as follows:
