CONRAD-FAIR DEBATE. The two front running candidates in the Democratic party's primary run for state governor, Mr. Larry Conrad and Senator Robert Fair, will be on campus in their only joint appearance in the entire campaign on Wednesday, April 28 at 12:00 noon in Room A28. Included in the program will be a 30-minute question/answer session, specifically designed to point out where the two candidates stand on the vital issues facing the state government. The program

will be moderated by Mr. Bob Flynn, political reporter, The Evansville Press. The debate is being sponsored by the Communications Forum, and is open to the public.

GUEST SPEAKER ON CAMPUS. Sergeant Clarence Shepard of Police Community Relations will deliver a lecture on Thursday, April 29 at 1:00 p.m. in Room A28. "Drugs in Relation to the Schools" will be the topic of discussion, with a film included in the presentation. Sergeant Shepard's lecture is being sponsored by the Student Education Association, and is open to the public.

HORIZON '76 PROGRAM. The third session in the Horizon '76 program will be held on Thursday, April 29 at 7:00 p.m. in A126. "Economic Potential of the Evansville Region" will be moderated by Eliseo DaRosa, Professor of Economics. Discussing opportunities for regional growth will be Dale Shook, Assistant Professor of Business, and Frank Stanonis, Commission for Environmental Studies, Commonwealth of Kentucky. Responding to their comments will be Frank McDonald, former Mayor of Evansville; Garth Whipple, Publisher, Mt. Vernon Democrat; and John Barnes, Assistant Professor of Geology. Following the presentation, the audience will be invited to participate.

The series is designed to draw on the expertise of a wide range of humanists, economists, political leaders, communications specialists, and community leaders as moderators, speakers, and respondents. The program will concentrate on providing a more comprehensive understanding of community values, problems, and forces, and thus, better prepare its participants to help effectively shape Evansville's future. All interested persons are invited to attend.

PETE SEEGER TO PERFORM ON CAMPUS. Pete Seeger, who counts among his hits such folk song favorites as "Where Have All The Flowers Gone?" "Guantanamera," "Turn, Turn, Turn," and "If I Had A Hammer," will perform in concert at ISUE on April 29 at 8:00 p.m. on the University Mall, and on April 30 at 10:00 a.m. in a jam/discussion session in the Forum.

PETE SEEGER TO PERFORM ON CAMPUS, CONTINUED. Pete Seeger was first attracted to "music of the people" when he visited a square dance festival in Asheville, North Carolina, in 1935. Due in great part to his influence, folk song clubs have started in hundreds of colleges, night clubs have taken up folk music, and it has become popular on radio and television. His infectious happy voice and versatile banjo have made him loved and sought after throughout the nation, indeed all over the world.

Pete Seeger is being brought to campus as part of the Ohio River Arts Festival.

INDIANA CLASSICAL CONFERENCE MEETING. ISUE will host the annual meeting of the Indiana Classical Conference, the state association of teachers and professors of ancient history and classics, on April 30-May 1. Daniel Scavone, Associate Professor of History, and Vice President and President-elect of that organization has coordinated the meeting. Topics to be discussed on Saturday, May 1, beginning at 9:00 a.m., include "The Classics and Creative Writing," by Donald Jennerman, Indiana State University; "Classical Influences on the Political Thought of America's Founding Fathers," by George Szemler, Loyola University, Chicago; "Greek Myth as Archetype of the Subconscious," by Donald Richardson, University of Evansville; and "Identifiable Greek and Roman Influences in Contemporary America: A New Secondary School Course," by Bernard Barcio, Pompeiana, Indianapolis. Beginning at 1:30 that afternoon, Donald Goertz of Ball State University will conduct a teacher workshop entitled "Women in Antiquity." All talks will take place in the Conference Center and will be open to the public.

ALUMNI BANQUET. The annual Alumni Banquet to honor 1976 graduates and induct them into the Alumni Association will take place on Saturday, May 1 in the International Room of the Executive Inn. The evening's festivities will begin with a social hour at 6:30 p.m., followed by a prime rib dinner at 7:30 p.m. and dancing at 9:00 p.m. One of the highlights of the evening will be the presentation of an honorary award to *Melvin Denner*, Acting Chairman, Division of Science and Mathematics, for outstanding contributions made to the Alumni Association over past years.

The evening will also double as a five-year reunion for the Class of '71, ISUE's first graduating class. Faculty who taught at ISUE in 1971 are encouraged to attend the banquet and reacquaint themselves with former students.

All ISUE alumni, faculty and staff are invited to attend. Cost is \$8.00 per person.

CONTEMPORARY ISSUES IN LAW. "Juvenile Court Law," the third session in the Contemporary Issues In Law series, will be presented on Tuesday, May 4 at 4:00 p.m. in Room 142A, Evansville Community Center, Walnut and Heidlebach. Dan Hopson, Indiana University School of Law and Associate Dean of the Faculty, will lead a discussion on the changing nature of the juvenile court system in the United States. Emphasis will be given to the discussion of relationships between the schools and the juvenile court.

CONTEMPORARY ISSUES IN LAW, CONTINUED. These seminars are sponsored by ISUE Center for Law Focused Education, directed by *Walter A. Hopkins*, Associate Professor of Sociology, in cooperation with the Indiana Project for Law Focused Education and the National Center for Law Focused Education. "This series of programs is designed to train teachers in contemporary developments in the law so that they might bring to their pupils a better understanding of law, and to increase the confidence of young people that they can work in and through the law in meeting their needs," comments *Dr. Hopkins*.

SECOND OFFICE STAFF TRAINING SESSION MAY 12-13. The second in a continuing series of training sessions for clerical and secretarial personnel will concern University purchasing policies and procedures. One session will be conducted May 12 from 2:00-3:00 p.m., followed by a second identical session on May 13 at the same time. Both sessions will be held in Room SC195. *William Muller*, Purchasing Agent, and *Richard Schmidt*, Controller, will conduct the sessions.

It is suggested that the person in each department primarily responsible for purchasing procedures attend the earlier session. Arrangement should be made for others to attend the second. Department heads are asked to excuse office personnel for this and subsequent training sessions, designed to acquaint secretarial and clerical personnel with procedures necessary to expeditiously utilize services of ISUE departments and offices. Whenever possible, attendance should be planned so that no office is unstaffed.

Sherrienne Standley, Publications Director, conducted the initial training session, April 19 and 21, which concerned the Duplicating Office. *Dan Oates* of Xerox Corporation was present to demonstrate some of the capabilities of the new copy center, which include making two copies per second, copying on both sides, copying photographs, running 16-110 lb. index, running in sets, collating, and producing high quality reductions.

Tentatively scheduled for mid-June is a session on departmental financial record keeping, to be presented by *Mr. Schmidt*. The Personnel Office is coordinating the training series.

BASKETBALL CAMP DATES APPROACHING. The ISUE basketball staff is conducting a three-week basketball camp for boys and girls from June 7-June 25 at ISUE Central Arena. The basketball camp will be divided into two sessions, with Session I meeting Monday through Thursday from 8:15 a.m.-10:00 a.m., and Session II meeting Monday through Thursday from 10:15 a.m.-12:00 noon. All participants in the camp should be 9 years of age or older. (Special cases must be directed to the ISUE basketball staff.) All high school participants must adhere to IHSAA regulations. Individuals attending the basketball camp must furnish all personal items. ISUE will provide a practice T-shirt to each individual. All dependents of ISUE administration, faculty and staff can attend the three-week session for the reduced rate of \$15.00. The fee to the general public is \$40.00, or \$15.00 per week. It has been announced by the Teacher Training and Licensing Commission that ISUE has received five-year approval, the maximum approval granted, for its Elementary and Secondary Education Programs. ISUE's education programs have now been granted approval by NCATE, the North Central Association and the State.

EAGLE GRAN PRIX WINNERS. Winners of the 1976 Eagle Gran Prix 5-mile women's race are Sigma Tau Hustlers, Champions; Phi Beta Chi I, 2nd place; and Phi Beta Chi III, 3rd place. The 32-mile men's race was won by Chi Gamma Iota, 1975 Champions, followed by Alpha Omega Psi in 2nd place and Sigma Tau Gamma I in 3rd place. Trophies for the fastest qualifying times went to Kim Booker of Sigma Kappa who completed one lap in 1 minute, 21 seconds, and Chris Kroeger of Alpha Omega Psi, who rode one lap in 1 minute, 9 seconds. The Eagle Gran Prix is sponsored by the Student Union Board.

DECEMBER RUSSIAN SEMINAR. The School of Graduate Studies and the Alumni Association of the University of Evansville have accepted an invitation to participate in Study Seminars in the education, life and culture of the Soviet Union in December, 1976. The program has been arranged by the Comparative Education Society and Dr. Gerald H. Read, Endowed Professor of Comparative and International Education, past-director of the Ford Foundation Project on Soviet Education, and author of the Houghton-Mifflin book, The Changing Soviet School. Dr. Earl M. Tapley, Dean of the University of Evansville School of Graduate Studies, has extended an invitation to two or three staff or staff couples from ISUE to attend the Study Seminars. Participants in the program will depart for the Soviet Union on December 20, 1976 and will return to the United States on December 30, 1976. By special arrangement with the Trade Union of Education and Scientific Workers, the cost will be \$909 per person. However, grants of \$150 to each participant in the program will be given toward the cost, so the total cost round trip would be \$759 per person.
