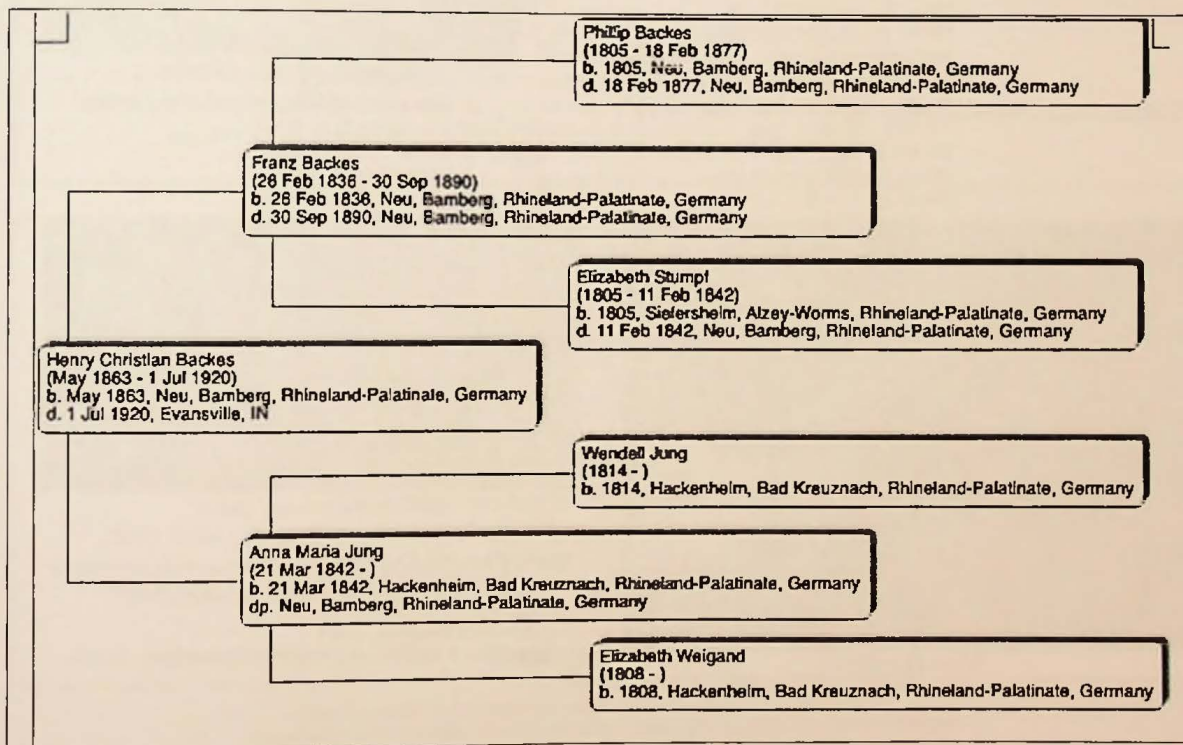

Introduction

This Backes family history was constructed from public records and contributions by family members and other genealogists. . Because of errors in public records, there are errors and misspellings in this book. This is not a complete history of the Backes family members. Since states determine what information is available for public view, some members have more information about them than others.

According to his passport application, Henry Christian Backes was born in Neu Bamberg, Germany, and emigrated from Germany, departing from Bremen on Ship Werna on or about 10 August 1884. He resided in the city of Evansville, Indiana. He became a naturalized citizen before the Circuit Court of Henderson County, Kentucky on 8 November 1889. He lived in Evansville, Indiana. His occupation was given as Merchant.

According to other researchers, Henry Christian Backes was the son of Franz Backes and Anna Maria Jung. His paternal grandparents are Phillip/Backes and Elizabeth Stumpf. His maternal grandparents are Wendell Jung and Elisabeth Weigand.

Neu-Bamberg is an *Ortsgemeinde* – a municipality belonging to a *Verbandsgemeinde*, a kind of collective municipality – in the Bad Kreuznach district in Rhineland-Palatinate, Germany. It belongs to the *Verbandsgemeinde* of Bad Kreuznach, whose seat is in the like-named town, although this lies outside the *Verbandsgemeinde*. Neu-Bamberg is a winegrowing village.

Neu-Bamberg lies in the *Rheinhessische Schweiz* (Rhenish-Hessian Switzerland) at the edge of the North Palatine Uplands. The land is hilly and characterized by a mild climate. Flowing through the village is the Appelbach, which once drove three mills in Neu-Bamberg. Of the three quarries that were once found in the village, one is still in business.¹⁰ Neu-Bamberg's elevation, as measured at its defining landmark, the *Kandelpforte* (clocktower), is 157.23 m above sea level.¹⁰

country of Germany



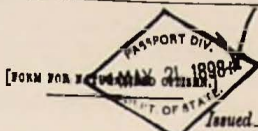

The following snippets from census records offer a window into the Backes family story. The records help construct entire family groups and identify relatives.

Censuses are taken every 10 years, starting in 1790. The majority of the 1890 census was lost in a fire. The most recent census available to the public is the 1940 census.

Census-takers were to visit each household. Beginning in 1850, every free household member was named and families were numbered in order of visitation. Census-takers did not ask people how to spell their names, thus, misspellings are common. Discrepancies do show up as the source of information may have been a child or neighbor, or language barriers may result in miscommunication and inaccurate information. Additionally, mistrust of the government may lead to falsehoods, especially about income or naturalization status.

Descendant Report

A descendant report is a text outline showing descendants of the source couple or source person. This document begins with one person, Henry Christian Backes, who is considered the source person, and looks forward in time — down the roots, as it were, from him.

This report uses the legal outline format. Each descendant in the family history report is assigned a unique legal outline number which symbolizes the descendant's relationship to the source person.

Henry Christian Backes, is assigned the number 1. His oldest child, Margaret, is assigned the number 1.1.

His second child, Maria Anna, is assigned the number 1.2.

His third child, Henry Vitus, is assigned the number 1.3, and so on.

The generation prefix, such as (2), is before the descendant's name and indicates the generation from the source person. The dashed vertical lines can help one follow the pathway up the ancestor lines. Each level of indentation in the outline represents a successive generation. The number of digits in the format also indicates the generation from the source person. For example, 1.2.3.1 shows a fourth generation, since there are four digits in the legal outline number. Read the numbers from right to left. For example, the person number 1.2.3 means the third child of the second child of the source person.

When there is a second marriage, the letters, "a" and "b", are used, where "a" represents the first marriage and "b" represents the second marriage. For multiple marriages, the letters "c", "d", and so on, are used. If either the husband or wife of the couple has multiple spouses, the descendants of their other spouses will not be listed.
